- 390-01** Broadwater County Area - 10 Permits - Successful applicants will receive one 390-01 License
- 586-01** Wheatland / Sweetgrass / Meagher & Golden Valley Counties Area - 50 Permits - Successful applicants will receive two 586-01 Licenses
- 599-00** Carbon County Area - 20 Permits - Successful applicants will receive two 599-00 Licenses
