- 380-01** Beaverhead, Gallatin, Jefferson and Madison Counties - 120 Licenses - Successful applicants will receive two 380-01 Licenses
- 390-01** Broadwater County - 20 Licenses - Successful applicants will receive one 390-01 License
- 586-01** Wheatland, Meagher & Golden Valley Counties & Sweetgrass North of I-90 - 50 Licenses - Successful applicants will receive two 586-01 Licenses
- 599-00** Carbon County - 20 Licenses - Successful applicants will receive two 599-00 Licenses

RESIDENT AND NONRESIDENT CONSERVATION AND BASE HUNTING FEE REQUIREMENTS

The 2015 legislature passed HB 140 that states, to be eligible to apply for a hunting license or permit a person must first obtain a **Base Hunting License** as a prerequisite. You must also purchase a **Conservation License** prior to applying for OR purchasing any hunting, fishing or trapping license. MCA 87-2-201

- \$8.00 2019 **resident** Conservation License as a **nonrefundable prerequisite**.
- \$10.00 2019 **resident** Base Hunting License as a **nonrefundable prerequisite**.
- \$5.00 Nonrefundable Application Fee**
- \$10.00 2019 **nonresident** Conservation License as a **nonrefundable prerequisite**.
- \$15.00 2019 **nonresident** Base Hunting License as a **nonrefundable prerequisite**.
- \$5.00 Nonrefundable Application Fee**
