Madison SRP Reports

- Nearly complete record of all Madison River commercial use
- Annual SRP report logs
 - Permittees required to report all commercial activities
- Enter/audit each report (2011-2020)
 - Calculate/confirm SRP fees
 - Track use
 - Enforcement

Standard Report Processing

- Initial report processing
 - Digitize SRP report logs
 - Compare report cover to report logs
 - Trips
 - 3% fee
 - Address/correct obvious issues
- “Final” report processing/data analysis
 - Combine and standardize data
 - Correct report/fee errors
 - Confirm/correct trip counts
 - Remove duplicate trips
 - Combine split trips
 - Remove ineligible \$0 revenue trips
 - Remove trips prior to being permitted
 - Prepare enforcement report
 - Analyze data

2019-2020 Trip Totals

- Complete records, but;
 - No historic tracking of trips/permit holder
 - SRP permit structure based on gross revenue
- Re-examine each 2019-2020 report and logs
 - Goal was precise, accurate trip counts for each permit holder
 - Confirmed/corrected trip counts
 - Removed duplicate trips
 - Combined split trips
 - Removed ineligible \$0 revenue trips
 - Removed trips prior to being permitted
- Extremely accurate/complete data for 2019-2020
