Legislative updates & discussion

Randy Arnold gave an update on the 2015 legislative session and the status of bills introduced by FWP. He invited CAC members to contact him if they have questions. FWP tracks bills and updates online, and CAC members can find a link to this info at fwp.mt.gov.

Tim Aldrich spoke on bills not introduced by FWP but that may impact FWP in some way. These include bills on topics such as trapping, law enforcement requirements, the water compact, hunter orange, habitat issues, and access laws.

Montana's current moose research project

FWP wildlife researcher, Nick DeCesare, gave a presentation on Montana's moose research project, initiated in 2013, and aimed at uncovering some of the key things impacting moose population numbers and mortalities in Montana. He discussed the need to gather more information on moose in Montana and across their North American range and reported some of the very early findings of this ten year study.

State Parks projects & updates
