### Permit Fees

The permit fee for commercial use on the Blackfoot River is **3% of gross revenue or \$115**, whichever amount is greater. Gross revenue is the unadjusted gross income earned from commercial use on the Blackfoot River and BLM and FWP sites along the Blackfoot River from January 1 through December 31, 2022.

**A Partial Fee Payment is required when you submit this application.** The remainder of the permit fee must be paid in full by January 13, 2023. Please follow these steps to calculate your Partial Fee Payment:

<b>A</b>	Estimate the total number of commercial trips you will take on the Blackfoot River from January 1 through December 31 and enter it here.		Example: 100 trips
<b>B</b>	Estimate the amount of gross revenue you expect to make on each commercial trip and multiply that amount by the number of trips you listed on line A and enter it here.	\$	Example: Amount of gross revenue per trip: \$450 \$450 per trip x 100 trips = \$45,000
<b>C</b>	Multiply the amount on line B by 3% (0.03) to calculate your <i>total estimated permit fee</i> . Divide this amount by 2 and enter it here. (Please round to the nearest dollar.)	\$	Example: .03 x \$45,000 = \$1,350 \$1,350 / 2 = \$675
<b>D</b>	Enter the amount in line C, <b>OR \$115.00, whichever amount is greater</b> . This is your Partial Fee Payment that is due when you submit your application.	\$	Example: \$675 is greater than \$115 Partial Fee Payment = \$675
