

## Madison River and Varney Bridge FAS Temporary Closure Rule Summary of Comments

Public comment was accepted on the Madison River and Varney Bridge FAS Temporary Closure Rule December 17 – January 13. Twenty-eight public comments were submitted. The majority of comments (23) supported the proposed rule and voiced additional concerns focused primarily on access, crowding, river passage, and adequate public notice. Two comments opposed the proposed rule, and three comments were outside the scope of this proposal.

The Department believes the proposed rule adequately addresses additional concerns by commenters. Temporary river and FAS closures will be minimized to the extent possible. The contractor will be required to notify FWP and other recreational interest groups at least 48 hours prior to any temporary closures. Notice of closures will also be posted at upstream access sites and through media reports. Passage around the construction site will be maintained by a minimum 40-foot wide by 6-foot high clear waterway opening. When temporary closures are needed to ensure public safety, the maximum time allowed for the temporary closure is 48 hours. FWP will be notified immediately upon completion of work to lift the temporary closure.

One opponent for the project does not support closing navigable waterways to public access at any time. The other comment stated that closing the Varney FAS is a bad idea because it will cause crowding on other portions of the river. Two comments were not applicable to this project, with their concerns better addressed through the ongoing Negotiated Rulemaking Process for recreational use on the Madison River. The other comment regarded traffic flow on the highway during construction and was sent to MDT.

	The Varney bridge boat ram is an extremely important access point on the upper Madison. Closing the boat ramp could potentially cause extreme congestion in other parts of the river, particularly during July through September. By the same token, closing the river to passage under Varney Bridge could also cause severe disruptions to the normal flow of recreational use on the upper Madison.

scullyoutfitting@msn.com	Road and bridge work should be completed during the "off" season, from October to April and not during the heavy use period of April through September. You will be forcing summer river users into an over-crowding situation by effectively closing down over 15 miles of water since there is no other access points between Storey Ditch and Eight Mile fishing access. This is a high-use boat ramp for both take out and put in. East side of the river needs to be usable by May and remain open. You will also not be able to communicate the river closing periods to everyone, since some of the recreational floaters will be floating the river during a two or three day period from the top of the river down and will be on the water for at least two days. You are closing the river for the convenience of the contractor and not paying attention to the actual users. 	I'm a 4th generation Montanan who grew up in Billings and I've been fishing the Madison River for 35 years. I guided on the river for a period of time during my college days in Bozeman. The Madison is an amazing river and fishery, and we are fortunate to have such a resource in southwest Montana. Unfortunately, it is being loved to death and I believe that the resource is suffering. I have not regularly fished the Madison in 10 or so years because it is so over-crowded it just isn't enjoyable to fight the crowds any longer. When I do, I get on the water at 6 am or so to beat the rush of drift boats. And this is rare, as I generally only fish it these days in the shoulder seasons and/or upstream from Lyons Bridge to escape the armada of drift boats, most of which seem to be guides. I have no statistics to back this up, but my opinion is that the fishing has suffered due to the crowding. I've got a buddy in Ennis who has been guiding the Madison for 40+ years and he is constantly commenting that the river is not what it used to be, even 10 to15 years ago. I've noticed that river etiquette has also diminished on the river and at the accesses and this is certainly due to over-crowding. Ignore the fishing aspect for a minute just the experience of floating the river is not that enjoyable any longer due to the over-crowding. That is a sad reality. I understand that over half of the angler days are from guided trips, the vast majority of which I assume are from out-of-state clients. As a small business owner, I empathize with outfitters who earn a living from guiding clients, but when half of the angler days on the river are from guides, that is simply too much. It's time for guided trips to be regulated. And do you regulate non-guided non-resident fishermen as well? I don't know, but probably something to think about. I certainly don't have the answers, but this river does not exist for the benefit of the outfitters and non-residents. Most MDT projects have a 3-week look ahead meeting each week during which a review of activity would provide a closure notice that could be posted and communicated to the local guides and shops limiting the impact of the closure to the section from the bridge downstream or landing from upstream floats. If closing one half of the river while leaving the other half available for floating past the bridge is not feasible, then at a minimum, floaters should be able to take out at Varney, thus leaving another section of the river to float (McAtee to Varney). 	Closing the bridge on the days/weeks that work necessitates is understandable. A blanket closure for floating under the bridge is overkill - especially for 8 months! Floating under the bridge on weekends should not be shut down - except in the event work is actively in progress.
