
I wish to express my enthusiastic support for the Grassy mountain land acquisition proposal associated with the Mt Haggin WMA.

This remarkably fortuitous opportunity to both expand the WMA for the public and make the recent acquisition of adjacent lands more robust for wildlife and fisheries is an opportunity that simply should not be missed. Though the primary driver for the purchase appears to be big game habitat and hunting access — the location of Oregon Creek on the property would seem to be an amazing addition to the enhancement of the native trout fishery project and public access to that awesomely unique resource that is unfolding. The lay of the stream through the area looks to open up a significantly greater stretch of stream for improvements to the WMA fishery along with future public access to enjoy that effort. The fisheries work taking place in the drainage has the potential to alleviate a tremendous burden on the Big Hole River system with respect to the Grayling issues and huge loss of historic range for Westslope Cutthroat trout and it would be black mark on all of us to pass on an opening to aid those species on public lands.

The expansion also allows for a larger area of contiguous land without fencing to facilitate wildlife movements. Hopefully, if the land can be included in the WMA, any new perimeter fencing will be constructed to a wildlife friendly standard.

The habitat value of this parcel along with the relatively easy access to public use, and prospect of increasing the power of ongoing upgrades to the WMA are invaluable compared to the prospect of seeing the land chopped up for a subdivision. I cannot help but feel that these two hundred and some acres will have a butterfly effect on the overall ecology of the wild lands of the area near and far.

The Montana Wildlife Federation (MWF) is our state's oldest and largest state-based wildlife conservation organization. We were formed in 1936 when hunters joined landowners to restore depleted wildlife in Montana, and for 83 years we have worked on key issues affecting wildlife, habitat, and access.

MWF is strongly supportive of the proposed purchase of approximately 244 acres of private land adjacent to the Mt. Haggin Wildlife Management Area (WMA) in Deer Lodge County by the Rocky Mountain Elk Foundation (RMEF) and the Department of Fish, Wildlife & Parks (FWP). This location is an important migration pathway for mule deer and elk that connects their wintering range with calving and fawning grounds. Additionally, this habitat supports calving and fawning within the WMA, as well as providing security for elk in the fall. Other non-game and game species such as moose, black bear, sandhill crane, and many species of songbird can be found in this area.

This location also has potential fisheries values as it borders Oregon Creek. FWP plans to reintroduce native westslope cutthroat trout as well as arctic grayling as soon as 2020. These plans, as well as the recreational potential presented through hunting and fishing, make this addition an exemplary conservation effort by FWP and RMEF.

MWF considers this an excellent use of Habitat Montana funds and commends the Department for preserving this land. Thank you for the opportunity to comment and voice our support of this project.
