

# DECISION NOTICE ASH COULEE CONSERVATION EASEMENT

# **DESCRIPTION OF PROPOSED PROJECT**

Montana Fish, Wildlife and Parks (FWP) proposes to purchase a conservation easement on approximately 3,400 acres in Valley County, Montana. The conservation easement will be funded by Habitat Montana and a grant from the Montana Fish and Wildlife Conservation Trust. Based upon a value determined by an independent appraiser the purchase of the easement would not exceed \$772,000. The easement, called the "Ash Coulee Easement", is comprised of native shrub and prairie grasslands, as well as breaks associated with the Milk River. The property has been found to be critically important to wintering migratory antelope and serves as a key linkage between summer and winter ranges for migrating sage grouse. The Ash Coulee Easement provides excellent year-round habitat for mule deer, white-tailed deer, sharp-tailed grouse, and a diversity of nongame wildlife. The easement would protect healthy blocks of native prairie and riparian habitat from conversion to other cover types, benefitting wildlife and agriculture, while also increasing public hunting and recreational opportunities.

## MONTANA ENVIRONMENTAL POLICY ACT (MEPA) PUBLIC PROCESS AND COMMENT

The Montana Environmental Policy Act (MEPA) requires FWP to assess impacts to the human and natural environment.

Formal public participation in the MEPA process was initiated with a public scoping process. Public scoping was conducted April 2017 to May 2017, wherein the public was asked to identify any issues and concerns related to this conservation easement proposal. Copies of the scoping notice were mailed to neighboring landowners, interested parties, and the Valley County Commissioners. Notice of the public scoping was placed in local and state newspapers, and on the FWP website. A total of 9 comments were received during the scoping process and addressed in the draft Environmental Assessment (EA).

The draft EA was released on June 10, 2020 with a 30-day comment period ending July 10, 2020. Legal Notice of the EA release and comment period was published in the Glasgow Courier and the Helena Independent Record. Public Notice was placed on the FWP Website and the information was shared via the FWP Region 6 Facebook page. Direct mailing and/or email notification was provided to adjacent landowners, interested parties, Valley County Commissioners, DNRC, BLM and NRCS. A public meeting was advertised and held at the Cottonwood Inn in Glasgow on June 29, 2020; four members of the public were in attendance. The Draft EA, the easement and the management plan were available to interested parties by downloading from the FWP Website. Hard copies were available at the FWP Region 6 office in Glasgow and were available at the public meeting in Glasgow.

# **SUMMARY OF PUBLIC COMMENT**

A total of 20 comments were received through the public comment period representing 19 individuals and 1 group. One handwritten comment was received during the public meeting, the remainder were received electronically. All comments received expressed support for the Ash Coulee Conservation Easement.

# **DECISION NOTICE**

Utilizing the EA and public comment, a decision must be rendered by FWP which addresses the concerns and issues identified in the proposed action.

FWP's analysis supports purchasing the perpetual conservation easement encompassing approximately 3.400 acres in Valley County, Montana that comprise the Ash Coulee Conservation Easement.

I find there to be no significant impacts on the human and physical environments associated with this project. Therefore, I conclude that the Environmental Assessment is the appropriate level of analysis, and that an Environment Impact Statement is not required.

After review of this proposal, it is my decision to accept the draft EA as supplemented by this Decision Notice as final, and to recommend proceeding with the proposed Ash Coulee Conservation Easement, contingent upon approvals by the Fish and Wildlife Commission.
