

# Antelope Master List

January 13, 2020

Specific proposed changes for 2020-21 are listed below. All other season components except calendar year rotation are proposed unchanged from 2019.

## Region 2

HD 215: Remove the 215-31 second opportunity B licenses.

## Region 3

HDs 338, 339, 340, 341, 350, 360, 370 & 388: Establish quota ranges for second-opportunity B licenses as follows:

341-30	50-500
350-30	25-250
360-30	25-200
370-30	25-250
388-31	10-100
799-30	50-4,000

HD 311: Change the 311-20 either-sex quota range from 150-350 to 75-300 with the quota remaining at 150.

Remove the 311-30 antelope B license.

HD 318: Boundary change- Change HD 318 to reflect the new addition of HD 329 in the eastern portion of the current district.

Decrease the 318-20 either-sex license quota and quota range from 250 (range 100-550) to 175 (range 50-350).

Decrease the 318-30 doe/fawn license quota and quota range from 200 (range 200-600) to 125 (range 50-350).

HD 329: Reestablish antelope HD 329 following the 2006 legal descriptions, with editorial amendments.

Create a new 329-20 either-sex license with a quota of 100 (range 50-300).

Add new HD 329 to the 900-20 antelope archery license.

## Region 4

HDs 470 & 471: Combine HDs 470 & 471 into one district (471) and remove current HD 470.

Remove the 470-20 either-sex antelope license.

**Specific proposed changes for 2020-21 are listed below. All other season components except calendar year rotation are proposed unchanged from 2019.**

Remove the 470-30 antelope B license.

Increase the 471-20 either-sex antelope license quota range from 25-400 to 25-700.

Increase the 471-30 antelope B license quota range from 5-400 to 5-650.

HDs 491 & 590: Boundary change- Change antelope HD 491/590 boundary to be State Hwy 294 so that both districts lie within their respective regional boundaries.

### **Region 5**

HD 512: Decrease the 512-20 either-sex license quota range from 75-200 to 25-200.

HD 514: Expand antelope HD 514 to increase hunter opportunity by modifying the eastern edge of the boundary.

HD 590: Adjust antelope HD 590 so that the entire HD lies within the Region 5 boundary.

Decrease the 590-20 either-sex license quota range from 450-800 to 200-800.

### **Region 6**

HD 600: Boundary change- Change HD 600 boundary by making HWY 241 the new eastern edge of the boundary.

HD 620: Boundary change- Change HD 620 boundary by making HWY 2 the new northern edge of the boundary. Change also applies to deer/elk/lion HD 620.

HD 640: Boundary change- Create a new antelope hunting district 640. to overlap with current deer/elk/lion HD 640. Proposed HD 640 would encompass the eastern portion of the current 670 antelope district beginning at State Route 24 and the eastern portion of the current 650 antelope district north of the Missouri River.

Create a new 640-20 either-sex license with a quota of 100 (range 50-300)

Create a new 640-30 B license with a quota of 25 (range 10-100)

HD 650: Modify the northeast boundary of HD 650 to follow the Missouri River instead of Highway 2.

HD 670: Shift the western boundary of HD 670 to the Harlem-Turner Road (Route 241). Change also aligns with the proposed change for deer/elk/lion HD 670.

Increase the 670-20 either-sex antelope license quota range from 25-500 to 25-2000.

Increase the 670-30 antelope B license quota range from 10-200 to 10-1200.

### **Region 7**

All R7 HDs: Rename the 700-20 and 700-30 pronghorn licenses to 007-20 and 007-30 respectively to reduce hunter confusion on where licenses can be used.

HDs 704 & 705: Create a new 799-30 doe/fawn second-opportunity license (quota 2,500, range 50-4,000) available OTC to hunters that draw a 007-20 and/or 007-30 pronghorn license.
