
Dear Commissioners,

Re: MT FWP - New Rule pertaining to limiting Teepee Lake in Flathead County to manually operated watercraft.

Dear Commissioner Aldrich and all persons concerned:

Last January the snow in the North Fork happened to be particularly perfect on both sides of the valley, a great time to slap on the skis and adventure. Teepee Lake looked like a perfect afternoon escape, not too much elevation gain and exposed to the sunshine (thanks to the Wedge Canyon Fire of 2003), a thing that happens seldom during the long winter months. Just as I reached the shoreline my front right ski hit something. I stopped and kicked, "whack" again, but this time something popped out of the snow. I bent down to brush off the snow and found a huge moose antler! This was my first trip to Teepee Lake after a decade of residence, perhaps because its not as "scenic" as other places in the North Fork. That notion has since been put to rest and with each season its magnificence transforms from sheds and snow to loon families and wetlands. Teepee Lake is a hidden gem in the North Fork. As visitation increases each year "special places", that happen to hold significant value to the ecosystem, are put under more pressure, especially those that are easily accessible by motorized vehicles like river accesses and through Forest Service roads. Fortunately Teepee Lake has remained intact due to its limited access and absence of motorized boats. We would like to ensure Teepee Lake remain intact by proposing that MT FWP adopt the language of watercraft being limited to "manually operated boats" only.


Since then I've learned that, thanks to the collaborative efforts between landowners, neighbors, FWP and USFS in the past, Teepee Lake is famous among locals as a place to observe common loons that have been nesting there for decades, at the least. After learning about the many unique qualities of loons, it has become apparent that the potential threat of motorized boats would be detrimental to the success of nesting loons as they require water free of disturbance. According to one local wildlife photographer that has spent hundreds of hours on Teepee Lake, loon chicks have been documented learning to feed on vegetation on the bottom of the lake. Motors will undoubtedly tear up vegetation and disrupt this pattern, not to mention the undisturbed runway loons require for takeoff.

It seems that managing increased human impact will forever be a challenge to public lands in Montana. Summer 2020, in particular, put significant pressure on the National Forests on the outskirts of Glacier National Park. Although half of the Park and all of the campgrounds were closed this year, that did not stop people from visiting. The result was that heavy use transferred to the surrounding public lands, most of which lacks infrastructure. Meadows in the North Fork have compacted into dust, river accesses and road sides have been converted into toilets and a significant level of negative impact upon important ecosystems have been put upon this place. The fear is that this may become the new "normal".

Preventative action is the least we can be doing right now. Together we can anticipate the worst, such as motorized boats on Teepee Lake, and plan for the best possible outcome for users and wildlife alike. Responsible and collaborative management is necessary and will help protect and preserve important places in our ecosystem, such as Teepee Lake, and ensure they stay intact for vulnerable populations like loons and moose, for the future generations of Flathead County and beyond to enjoy.

On behalf of the Board of the North Fork Preservation Association, I am proposing, in conclusion, that the only watercraft allowed to launch on Teepee Lake should be manually operated due to the potential disturbance to the historic loon population. Thank you so much for your time and your consideration.

Dear Commissioner Aldrich:

I am writing in support of an ARM to limit Teepee Lake, Flathead County, to manually operated watercraft. The reasons for doing so are well documented and clear. The Lake has a long history of providing nesting habitat and security for the common loon. The Lake's remoteness, limited access, and absence of motorized use have proved critical for loon reproduction.

I first came to this area of the North Fork as a twelve-year-old boy, sixty-two years ago. While age and longevity do not confer any special status, they do provide the perspective of change over time. Solitude is a rare treasure worth preserving, not only for ourselves and those who follow us, but for all the creatures that inhabit this special place as well.
