

How waterfowl hunting regulations are set...

Some ducks and geese migrate between the arctic in North America and Asia to South America and back every year. Because of this there are international treaties to protect migratory birds and define how waterfowl are managed. The Migratory Bird Treaty Act of 1918 is between the U.S. and Canada, Mexico, Russia, and Japan. In the United States, the U.S. Fish and Wildlife Service (USFWS) has the overall waterfowl management authority and sets a general framework for waterfowl hunting seasons that the individual states must follow. That framework establishes things like the earliest starting and latest ending dates; the total number of hunting days allowed between those dates; the maximum number of birds that can be taken by species and sex; how and when states can divide areas into different hunting zones and when zone boundaries can be changed, and if states can split the hunting season into different time periods. The individual states' regulations can be more restrictive than the federal frameworks, but they cannot be more liberal. In our state Montana Fish, Wildlife & Parks (FWP) sets waterfowl hunting regulations within the framework set by the USFWS.

Waterfowl are managed by way of administrative areas called flyways. There are four flyways in North America, and because they are all different in terms of hunter numbers and the ducks and geese that use them, each is managed separately with different season types and hunting limits. In Montana, there are parts of two flyways: (1) the Pacific Flyway in the western half of the state and (2) the Central Flyway in the eastern half (*see the map below*). The season frameworks established by the USFWS in the two flyways are often different from one another.

Federal frameworks define the maximum length of the season depending on waterfowl abundance and reproduction. States have the flexibility within those frameworks to define open and closing dates. We have traditionally opened waterfowl seasons the Saturday nearest October 1. In Montana, we try to recommend seasons that allow a variety of hunting opportunities when good numbers of waterfowl are present, while considering fall migration patterns and the likelihood that wetlands may freeze over, which may limit opportunities to hunt waterfowl.

The remaining question in this survey focus on the waterfowl hunting seasons in the Pacific Flyway and the Central Flyway portions of Montana (see the map on the back of the survey cover letter). The four-month calendar (Oct. 2020 – Jan. 2021) below is provided to assist you in answering these questions.
