I don't think that the LEPOC recommendations for the 2022-2023 mountain lion season should be implemented. The committee has not taken into account how human hunters and human infrastructure has potentially impacted the population size and distribution of ungulate species in the area. Simply increasing the number of lions that hunters can kill, in the hope that a decrease in the mountain lion population will increase ungulate numbers, thus giving both ungulate and lion hunters more animals to harvest is both over simplistic, as well as wrong and unfair to both mountain lions and ungulate species. More studies need to be conducted and reviewed on the human impact of ungulate populations, as well as other potential impacts, before putting all of the blame on mountain lions and other carnivores and omnivores.

Further, I don't think that decreasing mountain lion populations through hunting is an effective, or ethical way of preventing or mitigating conflict between humans and lions. A better use of time and resources would be to invest in public education on how to safely coexist with mountain lions, as well as other predators. This coexistence education can be disseminated among various age groups. And residents can be given the tools, training, assistance, and support to implement non-lethal deterrents, before lethal action against the animals is even considered.

Just because it might be harder for ungulate hunters to find animals to hunt, and just because lion hunters don't have as many opportunities as they would like to hunt lions, doesn't make it wise or right to decrease the overall mountain lion population without at least thoroughly considering other factors and methods before moving ahead with increasing quotas. Thank you.
