Removal of all bag limits on Rainbow Lake in northwest Montana

The Fish and Wildlife Commission approved the Rainbow Lake fish removal project during the December 2021 commission meeting. The Rainbow Lake removal project involves depopulating the fishery which is predominantly composed of non-native Yellowstone cutthroat trout with the subsequent restocking of native westslope cutthroat trout. This is an important area for westslope cutthroat trout recovery and the project will protect downstream westslope areas. Fisheries staff are currently preparing the environmental assessment for the proposed project. Fish removal is expected to proceed as soon as Aug. 15. Removing all bag limits on the lake prior to treatment allows the public an opportunity for unlimited harvest prior to the lake being depopulated.
