Willow Creek Addition Fee Title Acquisition Montana Fish, Wildlife & Parks Region 3, Bozeman 7 March 2022

Preface and Proposed Action

This Decision Notice has been prepared for MT Fish, Wildlife & Parks (FWP) to purchase in fee title an 829-acre parcel of private land adjacent to Mt. Haggin Wildlife Management Area. The parcel is located approximately 4 miles south of Anaconda along MT Highway 569 ("Mill Creek Highway"). It is owned by Gayle and Roger Burnett. The owners have agreed to sell the property for \$2,700,000, which was the appraised value about 9 months ago. Due to the age of the original property valuation, the appraisal is currently being updated. If the re-appraisal establishes a value below \$2,700,00, then FWP and the owners will renegotiate the purchase price to account for the lower appraised value. If the re-appraisal establishes a value above \$2,700,000, the owners have agreed to donate any value above this amount to FWP. FWP would pay the \$2,700,000 purchase price using Habitat Montana and possibly other partner funds, including a \$258,400 grant from the Montana Fish and Wildlife Conservation Trust. Upon purchase, the Willow Creek Addition property would be incorporated into the management of the existing Mt. Haggin WMA and be managed for its wildlife, fisheries and recreational values.

The Willow Creek Addition shares 2.5 miles of boundary with Mt. Haggin WMA and would contribute to the ecological function of the WMA. It contains big game winter range used heavily by mule deer and elk along with excellent pronghorn fawning and summer range. Mill Creek crosses the northwest corner of the property and Willow Creek flows across about 1 mile of the southern end. Genetics data has confirmed that pure strain westslope cutthroat trout occur in both bodies of water. The riparian habitat provided by these creeks sustain populations of moose, beaver, black bear, ruffed grouse, and numerous other small to mid-sized mammals, neotropical birds, bats, amphibians, and reptiles. Because of the diverse habitat ranging from forested mountain foothills, sagebrush, grasslands aspen groves and riparian, there is potential for numerous other game, non-game, and furbearing mammals and birds that occupy one, or rely on several habitat components, for parts or all of their annual requirements. The property also borders private land to the east that is protected under a conservation easement held by FWP. This furthers the ecological integrity of this property.

The proposed acquisition by FWP would ensure that Mt. Haggin WMA and this parcel would continue to serve the needs of wildlife and fisheries. In addition, this acquisition would provide additional public access for hunting, angling, trapping, wildlife-watching and other recreational opportunities.

Public Process and Comments

FWP is required by the Montana Environmental Policy Act (MEPA) to assess potential impacts of a proposed action to the human and physical environment. In compliance with MEPA, an Environmental Assessment (EA) was completed for the proposed project by FWP and released for public comment 31 January 2022.

Public comments on the proposed action were taken for 30 days (through 1 March 2022). The public was notified of the proposed action through the following avenues:

- An open house 5-6:30 PM on Tuesday February 8, 2022, at the Butte Area Resource Office.
- Two legal notices in: Butte Montana Standard, Anaconda Leader, Helena Independent Record.
- News release distributed to a standard list of media outlets interested in FWP Region 3 issues.
- Notice of this EA emailed, postal mailed or in-person to neighboring landowners, Deer Lodge County officials, local conservation groups, and other interested parties, including over 250 parties on the Butte Area Wildlife Biologist's email distribution list.
- Public notice posted on the Fish, Wildlife & Parks web page with Draft EA available and opportunity to submit comments online.

• Draft EA made available at FWP Region 3 Headquarters and Butte Area Resource Office.

Thirty-six parties submitted comments on the proposal. Thirty-three were in full support, two provided conditional support, and one party was opposed. All comments are listed in Table 1 in the order that they were received.

FWP thanks all parties that provided comments to this proposed action.

			While ADLC officials support public lands, public access, and FWP's efforts in wildlife management, we are deeply concerned that the wildlife management, including predators is not being taken serious enough in the ADLC area. While we do support this current land purchase, which expands the Mt. Haggin WMA, we also ask that the urban deer and predator management be taken more seriously. It would appear that the urban deer population in Anaconda continues to grow and that will only make the predator population grow as well. this would appear to place a liability potential on FWP when they have notice from the local government that the predator issue exists in conjunction with the FWP WMA. ADLC would like to work in partnership with FWP and would like FWP to better manage Region 2. Again, ADLCX does support this current land purchase provided that FWP take our situation serious and provide better management of the deer and predator populations in Anaconda and the surrounding area." FWP response: Foremost, FWP sincerely appreciates the support it has received from ADLC officials and the community over decades and we wish to continue a strong working relationship with them. Regarding ADLC officials' wildlife management concerns, several steps are being taken to address them. FWP Region 2 Supervisor is meeting with ADLC officials regarding urban deer and lions in Anaconda. FWP Region 3 has increased the lion quota in HD 319 which encompasses Mt Haggin WMA and this proposed acquisition. In addition, FWP Region 3 is exploring ways to expand lion hunting opportunities on Mt Haggin WMA during the winter closure period.

Finally, Willow Creek and Mill Creek both sustain wild populations of native Westslope Cutthroat trout and potentially threatened Bull trout. The diversity of species utilizing these lands underscore the value of this acquisition, separate and distinct from the human recreational experience.

We support the acquisition of these lands as an addition to the Mt. Haggin Wildlife Management Area so that these properties will become part of Montana's public land heritage (avoiding potential subdivision in to 27 individual 30-acre lots, as currently zoned) and will be managed for the recreational, wildlife and fish habitat benefits they can provide. This opportunity to enlarge public land ownership will not only provide greater public access to recreational lands but will also permanently protect the biologically rich habitat that contributes to the diverse wildlife in this area."

Final Environmental Assessment

The Draft Environmental Assessment, together with this Decision Notice, will serve as the final document for this proposal.

Based on the Environmental Assessment and public comment, it is my decision to approve the proposed action to purchase the Willow Creek Addition, an 829-acre parcel adjacent to Mt. Haggin WMA, pending Fish & Wildlife Commission and MT State Land Board approval.

I find there to be no significant impacts on the human and physical environments associated with this project. Therefore, I conclude that the Environmental Assessment is the appropriate level of analysis, and that an Environmental Impact Statement is not required.
