#### F. Region 7 Antelope

Proposal: Splitting Antelope Hunting District 007-20 into two districts

Proposed Change:

Create North and South Antelope Hunting Districts from what is currently HD 007-20 along the Yellowstone River.

MOGA Position: SUPPORT

Currently all six of the HDs in Region 7 (700, 701, 702, 703, 704, & 705), totaling over 35,000 square miles, make up a single antelope hunting district HD 007-20. Our proposal divides this single district into two districts of equal size using the Yellowstone River, a naturally occurring North/South boundary.

1) Resource Status /To what extent does this proposal address a conservation issue?

The department does not anticipate any biological effects by eliminating the Region-wide license structure and dividing the Region into two distinct antelope hunting districts split along the Yellowstone River. Quota levels will be recommended conservatively to evaluate the effect of changes in hunter distribution and number on antelope population numbers and harvest.

- 2) Hunting Opportunity/To what extent does the proposal address hunter opportunity?

  This is a simple and responsible change designed to increase management and regulatory effectiveness, optimizes hunter distribution and opportunity across the landscape and is easily enforced due to a simple naturally occurring boundary.
- 3) Hunter Distribution/To what extent does the proposal address hunter distribution and crowding.

A growing concern withing the Montana hunting community is hunter distribution and crowding. This proposal specifically addresses that concern by purposefully spreading hunters across the landscape across two hunting districts rather than one. Habitat conditions and status of antelope populations vary greatly across a 35,000 square mile area and by separating the district into two management units the Commission will be able to implement management prescriptions responsive more precisely to different conditions and abundance levels and address hunter distribution in a way not being considered under the current situation.

Because the Yellowstone River is a clear and naturally occurring boundary enforcement concerns are minimized. Spreading hunter effort and more precise antelope management is occurring in all other regions within the state; Region 3 has 21 Antelope HDs, Region 4 has 13 Antelope HDs, Region 5 has 9 Antelope HDs and Region 6 has 7 Antelope HDs.

4) Economic Impacts to Local and Regional Economies. Will the proposal have a positive or negative impact on local and regional economies?

Passage of this proposal will likely have little impact on local economies. However, the Department response related to permit issuance will. They have offered conflicting statements:

- "The department does not anticipate any biological effects by eliminating the Region-wide license
- structure and dividing the Region into two distinct antelope hunting districts
- Effects of the change are likely to be primarily social.

But then go on to say: Quota levels will be recommended conservatively to evaluate the effect of changes in hunter distribution and number on antelope population numbers and harvest."

There needs to rationale for "conservative quotas" and frankly any reduction in opportunity. Unnecessary reductions in permit issuance over historical levels will affect hunter opportunity and will have a negative impact economically.

- 5) Diversity of Hunting Opportunity. To what extent does the proposal add to or remove diverse hunting opportunities/experiences. See Above.
- 6) Landowner Concerns. To what extent does the proposal address a stated landowner concern or issue? Landowners we have discussed this proposal favor it because it prevents the "Goldrush mentality", where hunters descend on the area of the state with most abundant antelope which stresses landowners and results in crowding.

What about all the wildlife data for antelope that has been collected for the current 6 antelope hunting districts? Would they have to start over if they go to 2 separate antelope hunting districts? What about the data that has been collected for antelope hunting district 703, where the Yellowstone River splits this hunting district in half?

What about Fort Keogh BMA 306, the Yellowstone River splits this BMA in half. What are plans for other landowners who would have the same issue? I think this proposal would result in some landowners (ranchers) dropping out of the Block Management Program.

What are you talking about with the game damage assistance? The statement in the department response doesn't make sense. Damage control hunts should be for the entire region.

By eliminating the current region wide antelope hunting license in Region 7, would eliminate the opportunities for hunter to hunt the entire region whether on public or private lands, thus eliminating the number of hunters going to Region 7. As it is right now, hunters are more than willing to travel to eastern Montana (Region 7) when they know they have the opportunity to hunt the entire region.

The proposed amendment to split R7 antelope districts that was just posted yesterday 11/20/23 (2 days to comment?) but no associated justification or reasoning to validate such a change. I have 2 main comments concerning the process:

- 1) Whereas this proposal may be appropriate it is hard to provide meaningful, constructive comment when there is no justification for the change provided. Why is this being proposed? What issues or problems is it meant to address? How does this proposal address those?
- 2) With the biennial season setting process and public comment running now for months is this 11th hour proposal with 2 days to comment considered proper and adequate public vetting? This is not a small adjustment to season setting but a major change that would directly impact wholly 1/3 of the state's antelope hunters and almost half of the state's nonresident hunters. While this proposal may be supported by the public, is a last minute, 2 day period sufficient time for the proper public weigh in, discussion and vetting?

What is the justification?

Is it to address biological or population issues?

Are populations in certain areas depressed as a result of the current hunting system? Antelope populations in parts of the region have been depressed recently as the result of extreme drought and winter mortality but across the region this year seem to be recovering nicely from these extreme environmental factors. Harvest, at current levels, plays little role in population recovery. In areas with high numbers the regional response by adding doe licenses in certain areas has been effective.

Is it to address social or crowding issues?

The current system allows hunter numbers adjust quickly to areas with high antelope numbers and away from areas where numbers are depressed. The proposal would limit restrict hunter (and landowner) opportunity and flexibility to adjust hunter pressure to perceived antelope numbers. With the region being functionally 75% private landowners have the innate ability to restrict or increase hunter access as they see appropriate to their situation. The proposal would only limit that ability.

Is it to address perceived overcrowding on public lands?

With the bulk of accessible public lands located on the southern portion of the region splitting the region into north & south will do little to reduce crowding and in fact may exacerbate crowding if hunters are restricted to hunting only southern areas.
