I am a year round volunteer at Missouri Headwaters State Park and 4th generation Gallatin Valley resident. My husband does maintenance for FWP Region 3. As a result we reside in the park's employee housing throughout the year with our children. The increase in recreational activities at MHSP has been obvious, including camping, hiking, and of course hunting. Unfortunately that means there has also been an increase of rule/regulation violations in several categories, the most concerning of which being the ignorance of hunting regulations. Without action I fear that we will continue to see dangerous firearm practices in this tiny park, with greater potential for injury or death of a visitor, fellow hunter, or even myself, another employee or my children. MHSP is approximately 585 acres, there are at least 7 recreation sites with dozens of walking/hiking trails throughout the park, yet shots have been heard and gut piles have been discovered within 150 yards of camp spots in the campground. The size of the park makes it almost impossible to get away from recreation sites and visitors to hunt safely. Visitors do not wear hunter's orange, you should not need to wear orange to walk your dog or hike with friends and family within the immediate area of recreation sites. It is my belief that the park is simply too small and crowded not to have special restrictions in place.
