## Implementation of SB 280: Public Comment on 2023–2024 Bird Dog Training Licenses and Training Season Proposal (Combination of Alternative A and B)

We, the undersigned, offer the following comments for consideration by the FWP Commission pertaining to the implementation of SB 280 dog training rules for public land.

Background: The upland game bird resources of Montana represent an important public trust that is highly valued. Using trained gun dogs for hunting upland game birds is both a time-honored tradition and an ethical conservation tool for Montana citizens and visitors to the state. The level of interest in upland game bird hunting continues to increase and the reputation of Montana as a bird hunting destination continues to grow. For years, Montanans have raised, trained, hunted, and tested their dogs as individuals, members of clubs, and as professional trainers.

That has changed within the last 5 years as nonresident trainers with large numbers of dogs have begun concentrating during the late summer period on certain public lands. That level of use has become problematic for leaseholders, adjacent landowners, and hunters. Lack of enforcement of existing land use permit requirements is also a problem. In addition, the expanded use of online apps, including mapping services and video footage, have contributed to an increasing crowding issue for hunters on public lands and lands accessed through programs like Block Management or Open Fields.

Goal: To meet the intent of SB 280 and implement short-term regulations that allow for licensing of residents and nonresidents interested in training bird dogs on wild birds to:

- ascertain current levels of use and the distribution of that use,
- establish season dates for that training that provide protection for wild bird resources during the nesting and brood-rearing period,
- recognize and deal with differences between public and private land use,
- offer relief for areas experiencing increased levels of use during the late summer period, and
- provide differential opportunities for residents and nonresidents on public land.

Issue: implement over-the-counter *D5 Resident* and *D5 NonResident Dog Training Licenses* to train on wild birds in Montana. Training on birds raised in captivity does not require licensing. This helps the department collect and quantify current levels of use by resident and nonresident dog trainers to inform management decisions, including rule-making by the FWP Commission.

Position: Required by Statute - Support

Issue: Establish a bird dog training season on public lands to manage the impacts of dog training on wild birds, particularly during the nesting and brood-rearing periods for multiple species of upland game birds. Create differential training opportunities for Residents and NonResidents on public lands during the late summer period.

#### Position: Support

Issue: Both resident and nonresident bird dog training may potentially contribute to impacts on wild birds. However, the use and intensity of training at dispersed levels is likely not an issue, while areas being subjected to higher intensity of training and use do become problematic, particularly on blocks of accessible public land.

#### Position: Concur

Issue: The department developed:

Alternative A: The commission may vote to establish a bird dog training season on wild birds on public land that runs from August 1 through the last day of February. A dog trainer may not train on public lands if additional land use regulations prohibit access during all or part of this training window. A training license will be required by anyone training bird dogs using wild birds regardless of land ownership, although season dates only apply to public lands.

Alternative B: The commission may vote to select different start or end dates for a public land bird dog training season or for training prohibitions on public land.

Position: Support creating a bird dog training season on wild birds on public land (to include State School Trust Lands, Bureau of Land Management Lands, and U.S. Forest Service Lands and other lands managed by federal land management agencies). A dog trainer may not train on additional public lands (MFWP WMAs and USFWS WPAs) if other land use regulations prohibit access during all or part of this period. If additional land use permits are required by the managing agency for commercial activities, a trainer is responsible for acquiring these agency-specific permits or licenses. A D5 dog training license will be required by anyone training bird dogs using wild birds regardless of land ownership, although season dates only apply to public lands. Both residents and nonresidents, if properly licensed with a D5 dog training license, may train on wild birds on private lands with the permission of the landowner(s) under dates permitted by that landowner. It is recommended that landowners consider utilizing timeframes that offer protection for nesting and brood-rearing periods. Training season dates for public land:

## Resident D5 dog training dates for public land: August 1 - March 31 NonResident D5 dog training dates for public land: August 25 - March 31

Issue: To meet the intent of SB 280 to create opportunities to train bird dogs on wild birds and manage impacts relative to licensing of residents and non-residents, providing protection for wild bird resources during the nesting and brood-rearing period, recognizing and dealing with differences between public and private land use, and offering relief for areas experiencing increased levels of use during the late summer period requires ongoing management oversight and likely the need for additional rule-making by the FWP Commission.

Position: FWP to establish a Bird Dog Training Working Group involving individuals from major stakeholder groups to identify issues and make recommendations to regulations based on information that better informs management recommendations and commission decisions over time.

Dear Acting Director Temple,

Founded in 1936, the Montana Wildlife Federation (MWF) is the state's largest hunter advocacy organization consisting of thousands of Montanans who value sound wildlife and wildlife habitat management and our storied hunting and outdoor legacy. Together with our members and affiliated organizations, we ensure that wildlife conservation dollars are efficiently spent on wildlife-related activities, promote sound biology in managing our state's wildlife, and safeguard our hunting heritage. Our wildlife populations, specifically our upland bird populations, are the envy of the county due to a history of sound and innovative management practices. Therefore, MWF is grateful for the opportunity to formally comment on the **2023–2024 Bird Dog Training Seasons on Open Public Lands.** 

During the 2023 Montana Legislature, Senate Bill 280 was introduced and passed with broad support. This bill established bird dog trainers' need for a D-5 license. In addition, it directed the commission to set rules to better regulate the growing practice of large groups of dogs being trained on public land, specifically in eastern Montana.

MWF appreciates the Department's work with the legislature to protect our wildlife populations, and we recommend the department adopt Alternative B: The commission may vote to select different start or end dates for a public land bird dog training season or for training prohibitions on public land. We heartily support the proposed end date of the last day of February and the moratorium on training from March 1 through the start of the season. We would recommend a compromised state date of September 1st.

As noted in the cover letter provided by FWP, we know that the timing of many of our upland hatches means that birds will still be very immature come the beginning and middle of August. We are interested in chick mortality data associated with early training. The data provided by the Department would suggest that if we were to begin training in August, we would run a high risk of displacing young from their mothers, stressing them to the point of increased mortality rates. While delaying the start of the training season by a month appears to ask a lot of dog trainers who wish to use public resources to operate their businesses, we must always balance entrepreneurial and recreational use with the impact to the resource. We fear the potential adverse effects on our upland populations are too significant to justify starting in August. For this reason, we **request that the Department approve Alternative B** and delay the start date until September 1st.

There is no biological rationale for allowing bird dog training on wild birds on public land before individual birds are capable of surviving on their own seperate from a brood. Repeated flushing can displace young birds from their parent hen beyond distances where vocal recommunication signals faciliate reconnecting to the brood. Predation losses likely increase. Resident bird dog trainers can likely find private land for training. Non resident bird dog trainers (often displaced from other states prohibiting such training) can not only damage native bird populations but also displace birds to private lands before opening day of hunting seasons.

1) There should be no D-5 licenses issued for training of dogs on native birds on public lands before September 1. Personally I have had hungarian partridge and sharptails that could barely fly 100 feet on Sept 1.

2) No D-5 licenses should be issued to non residents

3) D-5 licenses should be issued to RESIDENT ONLY dog trainers beginning August 15 for use on private lands.

While I think that this proposal is done in good faith and with good intentions, I can see this unfortunately becoming a problem. It is possible for dog trainers to accidentally encounter wild birds while training, and those who own bird dogs (or versatile breeds) could be targeted for prosecution if they're in an area with nesting birds even if their dogs were not harassing birds. As the owner of a versatile breed, I use pigeons and rabbits for drags, but we occasionally encounter game birds in the off season. We then avoid these areas during the off season especially during the nesting months. I believe that there is an ethical use policy that supports recreation and public use without negatively impacting bird populations. There are many breeds of dogs other than bird dogs that may pressure wild birds even more by those Additionally, licenses may not actually prevent people from pressuring birds (those who travel to Montana to train their dogs on our birds are probably going to be able to pay whatever licensing fee), they can instead be an undue financial burden on those less fortunate. As such, perhaps additional signage on certain state lands that are likely to hold nesting populations would help users and trainers avoid areas that hold nesting birds/areas likely to contain nesting birds, and no license/permit would be required for lands not marked with said signage.

Commissioners,

I recommend the commission adopt a form of Alternative B, by establishing a dog training season on public lands only from Aug, 1 to Aug. 15 except in elk hunting districts that have early shoulder seasons on public land. Dog training on public land would be banned in these elk hunting districts and these districts would be expected to vary from year to year.

Department analysis of their proposal is remiss because it only addresses biological concerns of upland game birds while ignoring biological concerns of other wildlife especially ungulate big game animals.

Establishing a dog training season on public lands during January and February would be unwise because of disturbance to ungulate big game animals. For ungulate big game animals, January and February are usually the most critical months for survival. That's one reason our state's wildlife management areas are mostly closed to human activity in winter; so that wintering animals are not disturbed and needlessly wasting metabolic energy. Wintering animals on open public lands need to be considered.

Ungulate big game animals depend on thermal cover for winter survival because thermal cover helps conserve metabolic energy during a time of year when quality food sources are often limited. Game birds also utilize these thermal cover areas for the same reason. Dog trainers would focus their operations in and near thermal cover areas because that's where the birds concentrate along with ungulate big game. Neither ungulates nor game birds deserve canine disturbance in January and February.

Consistent with current department policy their proposal ignores any social/human elements of concern. So, I will provide some concerns.

Training bird dogs on public lands during late August just prior to September's upland bird opener and big game archery opener would likely haze game birds and animals to adjacent private properties closed to public hunting such as hunting leases and hobby ranches further reducing quality public land hunting opportunities. Elk displacement could further complicate elk management where public land borders closed private property. In districts where early elk shoulder seasons occur on public land, dog training could help defeat the purpose of shoulder seasons.

Honestly, our Daniels County area doesn't want any pre season training on state land... County Commissioners recently told me that requests to run water lines to abandoned house site has quadrupled as interest in buying a house/camper site in the heart of the greatest amount of state land in MT has some scrambling to sell an acre or two.

This means "resident" distinction will become tricky.

We urge for NO PERMIT because it creates another whole season our 1 game warden must monitor & also sends the message that we are willing to sell out for \$10 the dearest and most sacred land that belongs to all MT residents... at a time when all wildlife and cattle and horses are at their youngest and most vulnerable to unethical practices by way ward "smash and grab" trainers.

We urge NO TRAINING by residents until August 1st... and no training by non residents until Sept 1st.

Montana's state land hunting heritage is at stake. We cannot become a playground during agriculture's heaviest work load: having and harvest. The traffic is always almost unbearable: a school bus tipped over due to a training/hunting rig parked in the middle of the road.... We need help immediately.

If nothing else, shut down Daniels County State Land to all training. Sharp Tail Grouse are the target and are primarily in this northeast corner. Our quantity of State Land makes us an advertised target. We need your help, please.

I, Anthony Grimaldi, find this legislation to be completely arbitrary, utterly unnecessary, and severely detrimental to countless small communities throughout the state of Montana. Fish Wildlife and Parks will receive an insignificant financial benefit from the sale of dog training licenses, while forcing countless trainers from across the the country operating on both large and small scales to move their operations to North Dakota and/or South Dakota. The communities of the Dakotas will see the greatest benefit from this legislation. Neither wild game birds nor Montana residents will benefit from SB280 in any way, making this legislation borderline comical. If one wishes to improve upon wild game bird populations, improve upon the habitat in which they reside. If Fish Wildlife and Parks is in such desperate need of funding, raise the price of non-resident big game tags or raffle off another sheep tag for the Breaks.

While pursuing my degree in Wildlife Biology from Oregon State University, I studied every game bird from bobwhite quail to greater sage grouse extensively. At no point did I discover scientific literature suggesting that dog trainers are responsible for population declines in any game bird species. The loss, degradation, or conversion of habitat is almost always to blame for a decline in wild game bird populations (as well as ungulate populations), with mortality from disease being a minimal and cyclical risk factor.

I agree that it is easier to bully dog trainers than it is the land barons subdividing the state at an astonishing rate or the agricultural practitioners putting food on the table, but it does not make it right or just. Shame on each of you who voted in favor of SB280 for such trivial financial gain. Shame on those of you who voted in favor with little to no understanding of biological or ecological principles. And to the state and/or federal biologists who favored politics to science, shame on you. Those who vote in favor of SB280 or similar unnecessary legislation will continue to jeopardize the health of Montana's wildlife far more than any dog trainer will.

Dear FWP and Commissioners:

I am a biologist, landowner, hunter and bird dog owner. I do not train dogs professionally.

I oppose the current FWP recommendation to establish a bird dog training season for residents and non-residents beginning August 1 to February 28. The biggest problem we have in the field is the massive increase in non-resident hunters and bird dog trainers using our public hunting areas, including DNRC lands and Block Management areas.

It is my view that no commercial, professional dog trainers or dog training outfits should be allowed to use our public hunting areas at all. This is commercializing our publicly owned bird and wildlife populations at the expense of Montana citizen's access and enjoyment of OUR resource. I recommend the following:

1) Please consider setting separate seasons for residents and non-residents. Also, please consider making a distinction between professional and non-professional dog trainers.

2) Resident non-professional dog training season should be August 15th to March 31. This allows resident dog owners two weeks prior to the season to train their dogs and prepare for the upcoming bird season.

3) PROFESSIONAL bird dog trainers should NOT be allowed to train dogs on land open for public hunting AT ANY TIME. This should apply to resident or non-resident Professional trainers.

4) Resident professional dog training season should be August 15 to March 31, Non- resident professional dog training season should be the same, and both should ONLY BE ALLOWED ON PRIVATE LAND.

5. The fee for a dog training permit for residents, should be \$10. The fee for non-resident professional bird dog trainers should be \$100.

I feel this simple season structure places Montana residents first, protects the resource from commercial use, and protects the wild birds from disturbance during breeding season and other sensitive periods.

As a full time resident of Montana, a professional pointing dog trainer, and president of the Big Sky Field Trial Club, I ask that the Commission take the following points into consideration:

The push to limit bird dog training activities began a few years ago due to a seasonal influx of nonresident dog owners in Daniels County. Some of these individuals were training, others were scouting in anticipation of the start of bird hunting season.

To address this problem, and to provide Montana's nesting gamebirds with a quiet season for nesting and brooding, I propose the following:

1. Establish the requirement for a D5 license, which would be available for purchase over the counter, for training on wild birds

2. Close bird dog training on public lands from April 21 - July 31 each year

3. Close bird dog training on established BLM critical sage grouse habitat areas from daylight until 12pm each day, from March 1 - April 21

4. Close bird dog training on public lands for nonresident D5 license holders from April 21 - August 25.

Dear Commissioners,

I have reviewed SB 280 and have read FWP's cover sheet prepared for you. I am in support of additional restrictions on dog trainers to reduce the adverse impacts of this activity on wildlife especially young upland gamebirds.

I believe FWP's Proposed Motion to "approve the bird dog training season on wild birds on open public land in Montana during August 1, 2023, through the last day of February 2024, with no training on public land from March 1 through July 31, 2024, as presented by the department" is a start, but falls short of really addressing this issue.

The following are my concerns that I hope you will consider for incorporation in your decision and final rule making -

1. Does FWP have a definition for "dog trainer"? There is not one in the 2023 Upland Gamebird Regulations nor online. Does this apply to commercial trainers only or does it include a person who wants to take his dog out for exercise and hunting practice? As a resident will I now be required to obtain a D-5 license just in case my dog finds an upland gamebird while we hike on public ground? Will this prevent me from hiking with my dog on public land from March 1 through July 31?

2. End this season on December 31 to avoid stressing upland gamebirds and other wildlife during their critical winter period. This was the predominate reason why a recent proposal to extend the upland gamebird season through January was defeated.

3. Ideally this restriction should also apply to private lands too. Restricting this to only public lands may drive dog trainers to use private lands. This is a benefit for public hunters, but doesn't fully manage the resource. The increased mortality of dog training on young birds occurs regardless of land ownership.

4. This regulation doesn't need to apply to commercial trainers who use non-wild birds for their training.

5. North Dakota has already established dog training rules which seem reasonable. Please check them out at https://gf.nd.gov/gnf/licensing/docs/dog-train-permit.pdf.

Thank you for your time and I hope you will incorporate addition concerns into your rulemaking to make this a better effort.

Dear Members of the Fish and Wildlife Commission,

Please consider a restricted season for Bird Dog Training on Public Montana Lands. As a tenant of public lands myself and as a private landowner, I have great concern over a fast expanding of "mob" style bird-dog training on both public and private land. This type of activity is harmful to our precious native species of upland bird as documented in the white paper. I believe in conservation of native species and protection of both the animals and the habitat so that generations of future Montanas can enjoy their beauty and sport of hunting them. These dates also co-inside with peak livestock grazing seasons. These two actives do NOT work well together. Mob of dogs working a field, learning to hunt upland birds is a fast paced activity with running barking dogs followed by horsemen in chase is disruptive to not only upland birds, but deer, and livestock. As a public land lessor, we pay a rent to access peaceful grazing. Activities such as described is a great stress that results in livestock escaping and damaging fences, loss of weight and reproduction and lots of time that the lessor is financially responsible for.

Upland birds are wildlife species that are protected by hunting regulations to preserve their numbers. Bird dog training is should be regulated also as a sport. Licensing fees should be high enough to not only keep control of the number of dogs and trainers, but should also provide enough revenue to support FWP environmental assessment of such activity. Of particular concern; non-resident trainers should not be able to overrun public lands with such an intrusive sport at the expense of private Montana citizens and public land tenants. Our state should protect our citizens, our native species and our peaceful way of life.

I have owned and trained bird dogs for my personal enjoyment and hunting since 1993. I regularly exercise and train my dogs on public land but have always refrained from running them on wild birds from April 15th through the end of July to avoid the nesting and brood season.

Access to public lands for non-pro bird dog owners with one or two dogs like myself is very important as we often don't have access to large chunks of private land. March is an important month for getting dogs ready for spring hunt tests or trials after the off season. Likewise, August is an important time period to get our dogs in shape for the hunting season.

Consequently, I would urge the Commission to only limit training on public lands from April 15 to July 31. This would protect our birds during the nesting and early brood raising periods while still providing access for many non-pro bird dog owners during some critical training periods.

**Subject:** Proposed Motion in the June 8 FW Commission Agenda Item Cover Sheet 'Bird Dog Training Seasons'

Thank you for the opportunity to comment on this agenda item. To prevent possible future misinterpretation of the Proposed Motion, we request the following revisions.

### Proposed Motion as Circulated by Fish, Wildlife and Parks:

"I move that the Fish and Wildlife Commission approve a bird dog training season on wild birds on open public land in Montana during August 1, 2023 through the last day of February 2024, with no training on public land from March 1 through July 31, 2024, as presented by the department."

**Requested Revisions** - In order to stay in conformance with SB 280 and not lose the intent of said revisions, we respectfully request the following:

- 1. <u>Add</u>: Bird dog training over birds raised in captivity will be allowed year-round.
- 2. <u>Add</u>: with **no wild bird** training on public land in Montana during August 1, 2023 through..... (Comment: Wasn't SB 280 passed with an immediate effective date?)
- 3. <u>Clarify</u>: How is a member of the public or enforcement officer going to determine what is and is not 'bird dog training over wild birds'. This needs clarification. For instance, is taking your dog for a conditioning run on public land in July considered 'training over wild birds'.

#### **Rationale:**

The Big Sky Chapter of North American Versatile Hunting Dog Association, NAVDA, has 135 members that travel from the Missoula, Great Falls, Helena and Bozeman to participate in club activities. The group's purpose is to teach members how to train their bird dogs and train bird hunters in ethical and safe hunting practice. Ethical hunting practice includes training dogs so they do not waste game as well as observing common sense during nesting season.

Please consider the following:

- Big Sky NAVHDA is currently lucky to have access to private property for organized activities. That has not always been the case and might not be at some time in the future. In addition, members practice what they learn close to their homes, often on public land.
- As a group, Big Sky NAVHDA trains exclusively over birds raised in captivity and makes those birds available to members for their personal training. Our training routines and drills are limited to areas where wild birds are unlikely to be encountered or have been cleared. To produce dogs that meet our expectations, this training must be allowed to happen year-round.

- Montana Fish and Wildlife promotes programs to recruit and retain hunters. A key to recruitment and retention of bird hunters, is establishing a bond between human and the hunting dog. That happens best during training and before the hunting season.
- Bird dog training encompasses a wide variety of activities including pointing, retrieving, coming when called, not chasing game, leaving something alone on command, hunting for/with the human and not for themselves, and conditioning for 15 mile plus days during long walks with the handler. These hunting dog skills are key to ethical hunting. For those of us who do not own large properties and want to train our own dogs, we need the option to train on public land year round.

So Big Sky NAVHDA can accomplish these goals, the above revisions to the agenda proposal are necessary. It is hard to say who might pick up the proposed motion and consider it the comprehensive rule on bird dog training or construe any dog activity on public land to be 'training over wild birds' in the future
