RE: Comment on Amendments to Administrative Rules of Montana (ARM) addressing Grizzly Bears

We wish to comment on this section of the proposed ARM:

"(ii) Sport hunting is considered the most desirable method of balancing grizzly bear numbers with their available habitat, minimizing depredations against private property within or adjacent to grizzly bear habitat, and minimizing grizzly bear attacks on humans."

#### Comment:

The proposed ARM states: "Sport hunting is considered the most desirable method of... minimizing depredations against private property within or adjacent to grizzly bear habitat and minimizing grizzly bear attacks on humans". This statement is not supported by facts or science and is contrary to the published scientific literature on the relationship between sport hunting bears and human-bear conflicts. Hunting of bears has been documented in the peer-reviewed scientific literature to not reduce human-bear conflicts as stated by Obbard et al. (2014)¹ who found: "Human-bear conflict was not correlated with prior harvests, providing no evidence that larger harvests reduced subsequent human-bear conflicts. Given that variation in natural foods, harvest is unlikely to prevent elevated levels of human-bear conflicts in years of food shortage unless it maintains bears at low densities — an objective that might conflict with maintaining viable populations and providing opportunities for sport harvest."

The Montana Governor's Grizzly Bear Advisory Council said in their final report on p. 18: "...hunting is not likely to be an effective tool for conflict prevention or reduction".<sup>2</sup>

# Protecting Montana's wildlife, land, waters, and hunting & fishing heritage for future generations.

Another recent study<sup>3</sup> also demonstrated that sport hunting of bears did not reduce human-bear conflicts even though bear harvest increased significantly. The authors stated: "Human-bear interactions, incidents, and harvest were strongly related to the availability of natural foods in all analyses. Regulated, presumably sustainable harvest was ineffective at reducing human-bear interactions and incidents in the near-term and might have increased both. Our results support a long history of research showing that natural food availability is a primary driver of human-wildlife conflict. Programs promoting coexistence between people and wildlife, including education, capacity building, and management of unnatural food sources are likely to be the most successful at reducing conflicts between people and bears."

We believe that the ARM should be revised in section (ii) to say: "The most desirable and proven method to reduce both human-bear conflicts and grizzly bear attacks on people is to work with local residents on education, capacity building, and management of unnatural human-related food sources that bring bears into close association with people." Most grizzly bear attacks on people are due to surprise encounters with bears or to bears that have become food conditioned to human-related foods, especially garbage.<sup>4</sup>

Placing new or enhanced ways to kill bears into bear habitat like sport hunting or permits to landowners to kill bears that are "threatening" livestock without enhancing efforts to help residents reduce attractant availability and promote successful coexistence will just result in more dead bears and not reduce numbers of human-bear conflicts. Without enhanced efforts to secure attractants, bears will continually be drawn into such areas no matter how many are removed with hunting or permits to landowners or management actions. FWP, through their bear management specialists, in partnership with local groups should be the leaders in efforts to reduce the availability of bear attractants and to assist landowners in securing such attractants.

My recommendation is to issue hiker/biker permits for bear territory only on completion of bear interaction test. Human ignorance provoked most of the human-grizzly-black bear interactions I have read about in my 22 years of Montana residency.

Hello, here are my inputs to the future Montana FWP grizzly bear regulations. I hope they are of help.

- 1. Grizzly Permit is awarded once-in-a-lifetime limited entry-controlled draw for a spring hunt or a fall hunt permit.
  - a. The application fee will be \$100 per application per person.
  - b. Resident permit cost if drawn: \$500.
  - c. Non-resident permit cost if drawn \$3000.
- 2. To hunt Grizzly bears in Montana, hunters must successfully complete a Bear Identification Test administered by the Montana FWP.
- 3. The bag limit for hunting grizzly bears in Montana is one bear, once in a lifetime hunt per person, successful or not.
  - a. Bear cubs or sows with cubs are NOT legally allowed to be harvested.
  - b. Cub bear means a grizzly bear in the 1st or 2nd year of life.
  - c. By means of spot and stalk, using mechanical calling devices, or commercial attractants.
  - d. You must salvage the entire hide (with claws attached) and skull of a grizzly bear.
  - e. Evidence of sex MUST remain naturally attached to hide.
  - f. Bear meat DOESN'T have to be salvaged or removed from the field.
  - g. Bear hides and skulls MUST be sealed by the Montana FWP within 10days of harvest.
- 4. Grizzly Bear Permit quotas:
  - a. Spring 9 permits (Resident only)
    - 1 permit (Non-resident that requires to be with an Outfitter or relative within second degree of kindred)
  - b. Fall 9 permits (Resident only)
    - 1 permit (Non-resident that requires to be with an Outfitter or relative within second degree of kindred)
  - c. 1 permit by auction open to all to bid. Good for the spring or fall season.
  - d. 1 permit by raffle open to all. Good for the spring or fall season.
- 5. Seasons for limited entry-controlled draw permits:
  - a. Spring Grizzly Bear hunts conducted April 1 June 15
  - b. Fall Grizzly Bear hunts conducted September 1 December 31

You can't restrict human advancement into grizzly areas unless you start buying all potential property in grizzly habitat. So your options are to keep the grizzly population at today's numbers and when conflict happens decide what you will do with problem Bear. You can choose to relocate as standard practice or dispatch extremely bad bears. You should choose instead to relocate bad bears from western Montana to Yellowstone ecosystem and visa versa to improve bloodline. Because the ecosystems will never get closer because of human population growth.

Dear Montana Fish and Wildlife Commission,

Bear Creek Council is a community-based wildlife conservation and ecotourism organization based in Gardiner that works on key issues affecting our community and its tourism economy. We strive for practical solutions to the complex issues around the abundant native wildlife in the Gardiner Basin and Yellowstone National Park. We also promote our incredible, world-class wildlife resources as a sustainable asset that benefits our community as we welcome people from around the globe.

We are writing to express our serious concerns about the incorporation of SB295 into Montana's grizzly bear management plans. SB295 is bad policy that places the interests of livestock producers over everyone else on our public lands, shows no commitment to long-term grizzly bear conservation and management, and gives Montana a poor image. While Bear Creek Council is not opposed to sharing our public lands with livestock producers, we will not accept a system in which their interests are placed above all others, including those who value native wildlife like grizzly bears.

SB 295 allows for the issuance of kill permits for grizzly bears deemed "threatening" livestock, yet it has no definition of what threatening is. It gives broad discretion to the Montana Fish, Wildlife and Parks Director to issue those permits, and has no guidelines or standards for permits. And it has no time limits on the permits, meaning it will lead to the death of non-conflict grizzly bears. This is counter to Montana's decades-long commitment to grizzly bear restoration and conservation.

Furthermore, this bill is dangerous. Having ranchers with permits shooting at bears will lead to wounded animals on the landscape. This is not appropriate on public lands, where people are out hiking, wildlife watching and pursuing other recreational interests. The idea that we will allow this is impractical and setting our state up for disaster.

Finally, SB 295 would allow the killing of the grizzly bears most important for connectivity of the major populations in the Northern Continental Divide (NCDE) and Greater Yellowstone ecosystems (GYE). The bears outside those designated recovery zones are moving into larger public land areas that are excellent bear habitat, and to target them is wrongheaded, counter to a commitment to grizzly conservation and will further set us back from a delisting from federal protection and ultimate state management of our state animal.

This bill was supposed to address concerns from the U.S. Fish and Wildlife Service over bills passed in the 2021 Legislative session that allowed the killing of grizzlies "threatening" livestock. Instead of addressing that, SB 295 makes state law worse. It reflects an early 20th Century attitude toward grizzlies, one that seeks to kill them on public lands that all Americans own and enjoy, and where we value native wildlife.

The implications of this bill for Montana are significant, and it is unacceptable that we would place the interests of a handful of ranchers with leases on our public lands over everyone else.

For those reasons, we believe rulemaking is ill-advised and premature at this time.

Habitat: State and national forests require proper management (particularly timber harvest) to sustain the highest and best use of a renewable resource while reducing the heightened risk of catastrophic forest fires in the current environment. Managing forests to propagate a troublesome and dangerous grizzly bear population is a seriously wrong and mistaken undertaking.

Hunting and recreational use: Regarding grizzly hunting, Montana FWP has already proven that they can not follow their own stringent rules in conducting Grizzly Depredation Hunts...as they certainly did in early May of 1988 with a large male grizzly on the Rocky Mountain East Front out of Augusta. That problem bear received considerable coverage in the media about the time FWP broke their own hunt rules and permitted a "non-timely" hunt for the bear by a non-resident hunter who could not arrive on site by the designated time. The delayed hunt allowed the bear to move to less advantageous terrain with reduced visibility, where the hunter wounded it...and it was not recovered. I suspect it was at considerable department expense (ultimately paid by sportsmen and/or taxpayers) that multiple attempts by FWP personnel finally resulted in the dispatching of this large male grizzly via helicopter over the continental divide in (I believe) August of 1988. What a travesty that an experienced resident hunter who was packed, sighted in and had verified he would be on site the next morning by 6 AM was passed over in order to afford a non-resident the delayed opportunity...even though that meant breaking the department's own stringent rules of the depredation hunt.
