Agenda Item: 2024 Public Use Rules Deviations

Background: Montana Fish, Wildlife & Parks recently completed a consolidation of public use rules that serve all recreation and conservation properties administered by FWP (ARM 12.12.101-140). These define rules for FASes, WMAs, and other FWP-owned public use sites. Deviations to these rules require commission approval and are listed in the attached master list. Unless otherwise noted as new, these deviations are a continuation of the current status and management practice at the site(s), noted as existing. Proposed rule deviations are in reference to the following ARM rules.

- 12.12.105: Fee Compliance and Closure proposed rule deviations related to specific site closure times due to public safety, seasonal accessibility, staffing capacity.
- 12.12.106: Property Disturbance proposed rule deviations related to firewood collection allowed on site.
- 12.12.107: Designated and Dispersed Camping Sites proposed rule deviations related to extending camping stay limits beyond the seven-night stay limit in a 30-day period during the non-peak season, providing and establishing additional camping opportunities, and specifying camping designations and restrictions. Non-peak season is defined from the third Monday of September through the third Thursday of May.
- 12.12.109: Food Storage proposed deviations related to food storage rules that will be applied at listed sites to reduce wildlife conflict.
- 12.12.111: Domestic Animals proposed rule deviations related to areas where pets are allowed/not allowed, and specific restraint requirements for pets at listed sites.
- 12.12.112: Livestock proposed rule deviations related to the use of livestock for recreational purposes and spatial rules related to that use.
- 12.12.113: Weapons proposed deviations related to rules restricting the use and discharge of specific weapons.
- 12.12-114: Hunting and Trapping proposed rule deviations related to where and when hunting and trapping is allowed within a site.
- 12.12.115 Motorized and Non-Motorized Vehicles proposed deviations related to rules allowing the use of snowmobiling.

FWP proposes adoption of these rule deviations for one year, to be reviewed annually.

Public Involvement Process & Results: The public use rules went through MAPA, which included a robust public comment process, and gave the public an opportunity to comment on the public use rules at least three separate times. FWP received comment through this process on also offering future public comment on any rule deviations. The department will solicit public comment prior to the August commission meeting. Public comments will be posted online and provided to commissioners at least two weeks prior to the August commission meeting.

Alternatives & Analysis: The rule deviations FWP proposes the commission reapprove (i.e., existing) have been supported by current and past commissions over the past decade or longer. The proposed new changes are listed with justifications in the attachment. For both the existing and proposed deviations, the commission may adopt, modify, or reject any one or all of them. In general, the proposed deviations accommodate unique local circumstances.

The commission has three alternatives: 1) to approve none of the existing or proposed rule deviations; 2) to approve some of the existing or proposed rule deviations; or 3) to approve all the existing or proposed rule deviations.

Agency Recommendation & Rationale: FWP recommends readoption of the existing rule deviations and adoption of the proposed rule deviations as presented. The recommendations support consistency and clarity regarding the opportunities and rules for specific sites.

Proposed Motion: I move the Fish and Wildlife Commission reapprove the existing rule deviations and approve the proposed rule deviations as presented by the department.
