Seasons in Western and Central Montana are too long. Populations of all species are impacted negatively by allowing a 4 month season and pushing many species onto private land where trespassing citations have exploded. Add to that a huge influx of inexperienced new hunters that have very low hunter ethics when coming in contact with other hunters pursuing big game and waterfowl. Just this last season, I personally have had many more negative interactions with upland hunters especially pheasant hunters this last 2023 season. I have personally been put in several situations where upland hunters have shot at myself and people in my group while we were waterfowl hunting. We were set up with large decoy spreads, so it is pretty obvious that other hunters are present and upland hunters just push right up. In many cases they have walked right by our parked vehicles knowing that we are there, expressed to us in parking areas that they are going to hunt even though they know or should reasonably know that we are there. When having interactions with these individuals they have expressed that they have every right to hunt wherever they want and most actively will harass and place themselves to interfere with waterfowl that approach our decoy spreads.

Also, populations of pheasants in particular as well as partridge have been dropping in many of the areas which has been documented both in FWP studies as well as my personal observations. Examples include CSKT lands, Freeze Out Lake, Fresno Reservoir, and Warm Springs near Galen.

I have spent many hours in the field in all of these areas and have observed some of the lowest number of upland birds and a huge increase of new hunters. FWP needs to look at bird populations, hunting access, hunting pressure, and hunting ethics much better than they are currently. By having such a long season, populations are trending down due to harvest. In the past, shorter seasons allowed for better hunting opportunities and did not have a larger impact. Add to this poor nesting survival rates and increased predation from exploding populations or raptors, foxes, coyotes, and skunks.

At the current levels, by using an over simplified set of regulations that don't address specific populations, the current regulations will continue to negatively impact upland game hunting for pheasant and partridge just like it has for the native sharp tail and sage grouse populations which FWP has done extensively over the past several years.

Greater sage-grouse (sage-grouse): I would ask you consider two changes to sage-grouse hunting; 1) please consider allowing a hunting for all or a part of December. For many, the desire to hunt sage-grouse is in the opportunity to shoot an older, well feathered bird. This just doesn't happen in September. Young birds have not grown a complete set of feathers and the older birds are replacing feathers, molted in the previous months. Shooting a bird worthy of mounting is at best difficult. In December, the birds are better feathered and have the potential to become specimens worthy of mounting. It is my belief the numbers of hunters wanting to pursue sage-grouse at this time, would be limited, but the opportunity would be available; and 2) consider changing the early season dates from September 15-30. So many broods are in the road ditches, alfalfa fields or near water during the early part of the season, and as such are relatively easy to find and harvest. Most problematic is the impact on adult hens. Sage-grouse are not like other upland game birds in that they live longer, have smaller brood and respond less rapidly to positive changes in habitat conditions. Sage-grouse hens have learned how to survive and more efforts needs to be made to protect these successful nesters.

Gray Partridge: Considering lowering the bag limit from 8 birds/day to 5/day. Being able to harvest 8 is excessive. Montana and Idaho are the only states in the northern Great Plains to allow a hunter to harvest 8 birds/day. North Dakota, known for their robust Gray Partridge populations allows 3/day. Biologically, the current limit may not have an impact on long term populations, but the same could be said of pheasants. Part of the justification is to spread out the opportunity for take.

I am really happy to see the latest proposal to adjust the start date of the upland season for nonresidents to September 15th. With this change it will take off the early season pressure from the young birds. With that being said it would make sense for the bird dog trainers to follow the same dates. Resident trainers can start 9/1 and nonresidents can start 9/15. I believe this will alleviate confusion in the field if a non resident is spotted "training" but he is accidently turned in as a hunter out of season. Our game wardens in region 6 are spread thin as it is. They do not need to be making unnecessary stops trying to decipher if a nonresident is training or hunting prior to the proposed September 15th date.

Another change I would like to see is an upland season similar to North Dakota. Nonresidents in ND are only allowed to hunt two 7 day periods and they are not allowed to hunt the first week of pheasant season, unless they own land in ND. I would like to see the opening weekend in Montana as a resident only opener. Being from and still living in Froid, one of the hot spots for pheasants, the opener is usually total chaos. If the opener was limited to only residents the pressure on the young birds would be spread throughout the rest of the season.

Depending on what the local reservations determine with their upland season, the counties bordering the reservations could see another increase in hunter numbers as well as more pressure on our local birds.

Good morning, I would support both amendments that have been proposed to the Upland Game bird season. I would also propose that the out of state hunters are limited to only being able to hunt in a 10-14 day hunting season. Having the season open for 4 months may be ok, but each hunter can only purchase a 10-14 day ticket. Letting anyone buy a license to be able to hunt for 4 months is insane. I would agree that most people don't hunt for nearly that long, but there is a possibility. After this hunting season, our bird population is very low, even lower than it was the last two years after suffering severe drought. The hunting pressure this season was higher, and the trespassing was at an all time high. To say me and my family hate and dread hunting season, would be a massive understatement.

Law Enforcement- To ask one FWP officer to cover from Bainville,MT to roughly Frazer, MT and north all the way to Canada, is insane. That is the size of a small state back on the east coast. Officer Linder needs help to cover such a large area. My proposal, obviously, more officers, and, anyone caught trespassing and hunting should forfeit their current hunting license and be banned from purchasing a license for the next 3 years. Give the agents some teeth to work with for law breakers. The \$85 fine is a joke to a person that is spending thousands and traveling from literally thousands of miles away. I honestly saw every license plate in our nation, except Hawaii, this year during either the bird or deer season.

Personal Safety- I've now had 2 different hunters swing a shotgun in my direction as i was telling them that they were trespassing and that they needed to get off my property. I consequently now carry a pistol with me anytime I'm going to talk to a hunter.

Lost Income- Our farm has been using Land Trust for the past 3 years, this year, we refunded 3 groups over \$1500 because when our hunters showed up on our land to hunt, someone was already there trespassing and hunting, so we felt it was the right thing to do in refunding them their paid access money.

Hunting season has now become a 'cash cow' for FWP up here in the Northeastern corner of MT, you better start taking our problems seriously, or there will be thousands of acres shut down to all hunting, and eventually, there will be very heated, and armed conflicts, if these issues aren't addressed. I listen to my friends and neighbors in our local businesses, the tolerance for these hunters is getting very low. It is not uncommon for pickups to be parked right on the road, that doesn't work very well when farmers are trying to move large combines down the road to harvest the next field, and there sits a pickup, right in the way. I know one farmer that told them to move, or his semi was moving it, when the semi got closer, the hunter finally moved, but not willingly.

Like it or not, John Dutton's attitude and methods of protecting his land are going to be adopted up here in the corner, if Helena doesn't get off it's ass and listen. We own the land, you work for us!

- A 4 month UGB hunting season is too long. Shortening to three months by opening on September 15 and closing on December 15th would reduce the harvest, and stress on potential spring breeders in the winter, thereby enhancing hunter success and protecting the resource.
- Prairie bird bag limits are excessive, and unsustainable in the long term. STG daily bag limits should be reduced to 3, and partridge to 6 or less. Possession limits should be reduced to 3X daily bag limits. The department should emphasize a quality outdoor experience, as opposed to harvest numbers. Claims to the contrary, no one hunts UBG's for sustenance when the purchase of an organic chicken at their local market is much more cost effective. Currently some UGB hunters are shooting limits daily, and feeding birds to their dogs.
- _ Dog training for residents currently starts too early and negatively impacts UGB populations by prematurely dispersing late and second hatch family groups. Dog training for both residents and non-residents should start no earlier than August 15, and September 1 would be preferable. Non-resident commercial dog trainers stress, and increase the wariness of, UGB's, thereby negatively impacting hunting opportunities, yet their contributions to local economies is comparatively miniscule.
- Restrictions/seasons for dog training on public land should also be applied to private lands for these properties to qualify for enrollment in the Block Management program.
- Montana small game licensing fees should be increased for both residents and non-residents, and brought in line with those of North Dakota and South Dakota. The longest term non-resident license should be no greater than 14 days, with 10 days preferred. Non-resident UGB hunters desiring to hunt longer should be required to purchase multiple licenses.

And these out of state hunters often are inhumane and unethical in the treatment of their dozens of dogs they are training for clients. The only one who benefits from this atrocious practice is the trainer. The dogs suffer, the upland birds are killed and coveys broken up and scattered, ruining the hunting for us Montanans two weeks or a month before hunting season begins. I saw a trainer last year with 54 very skinny dogs, living in appalling conditions in the Plentywood public campground. He then moved on to the Scobey area. They should be charged exorbitant fees for training permits to discourage them from coming up from the southeastern US to train here in Montana where the weather is cooler early season.

Thank you for this opportunity to comment. These amendments are heading in the right direction, but I would strongly support efforts to curtail non-resident hunters even more. Like maybe limited number of non-resident licenses sold, and severely limiting the number of non-resident training permits sold.

To the MT Fish and Wildlife Commission:

With respect to the proposed amendment that moves the start of the season for non-residents to 15 September, I would like to request the proposal be withdrawn/dismissed. The rationale behind the request is that there is very little (if any) hard evidence linking resource constraints, habitat damage or depleted bird populations to the presence of non-resident hunters in early September (any correlation is likely to be spurious one). As a data professional, I can only surmise that anecdotal and statistically invalid observations are being used to support such a proposal. If the proposal is accepted, the state of Montana can expect significant economic damage from a drop in tourism revenue—impacting Montana resident owned outfitters, restaurants, hotel/motels, gas stations, sporting goods stores, etc. Specifically, the commission and Montana's economic authorities should expect significant reductions to non-resident hunter licensing revenue since a 15 September start will put the state in direct competition with the openers of states such as North Dakota and Idaho.

While I understand the concern regarding professional dog trainers bringing in numerous dogs and the disruption that can cause to native bird species, this amendment does not do anything but negatively impact the well-intentioned non-resident sportsman and numerous Montana businesses.

Proposed Solution: Managing Crowding Issues for Upland Hunting in NE Montana

In our efforts to address the crowding problems experienced during the non-resident upland hunting opener, the NE Montana FWP is considering a potential solution: moving the opener to September 15th. However, upon further analysis, it becomes evident that this approach may not effectively alleviate the crowding issue. In fact, it is likely to exacerbate the problem by condensing the hunting season into a smaller window of time, leading to further congestion on public lands and BMA's. Moreover, this change will have significant negative consequences on our local businesses, including eateries, gas stations, hotels, outfitters, and general stores, which heavily rely on hunters as a source of revenue.

As someone who prioritizes the well-being of our wildlife, I must emphasize that this shift in the hunting opener date does not represent an appropriate approach to wildlife management.

If crowding remains a pressing concern, allow me to propose an alternative solution: limiting non-residents to purchasing a maximum of two 7-day licenses per year, with the condition that they cannot be used consecutively. By requiring non-residents to purchase each license individually, we effectively double the licensing revenue for the state. This proposal does not restrict hunting opportunities for anyone and it does not harm small businesses in Montana. On the contrary, it actually increases revenue for the NE Montana FWP and addresses the root of the problem: non-resident hunters camping in Montana for an extended period of time.

As a landowner, state land leaseholder, farmer, and rancher in Daniels County, I urge the FWP Commission to consider full support of the accompanying amendments to the Upland Game Bird Seasons.

We continue to see a nearly 30% increase in Block Management sign in every year for the last 4 years. From that data we can extrapolate that Daniels County State Lands must be experiencing increasing presence and pressure accordingly. Daniels County has the greatest percentage of State Land - 26.4% - of any of the 56 counties.

The advertising by the American Kennell Club of the aforementioned fact insinuates that trainers can come any time and "train for free" on the best wild birds the country can offer. This too has led to even more vehicles and campers on the roads, camping ditches and on state land and private pastures.

Ranchers are experiencing increasing incidents of bird dog trainers running their horses/training dogs through pastures with cattle - private and state land intermixed as well as lease state land. (This style of training involves dogs running roughly 900 yards ahead with the trainer chasing behind horseback)

Contracts for Block Management acres that prohibit horse back activities are being called into question as land owners are receiving payment to be enrolled in Block but then allowing bird dog trainers to pursue birds that hunters would rather NOT be harrassed. Landowners are often enrolled with CRP acres whose federal contracts are being questioned because animal traffic (horses and cows) is not permitted during certain times, yet trainers with horses and dogs are canvassing the CRP acres....

17% of Daniels County lies within the Fort Peck Reservation. Visiting with Scott Azure, Chief Tribal Wildlife officer, confirmed that events leading to the sudden closure of bird hunting on the Reservation included the unprecedented pressure of non-resident bird dog trainers AND hunters. In turn, when the tribes meet to set their seasons in February, they plan to close down all bird dog training. Their position on non-resident hunting remains un-determined.

In response to tremendous bird and deer hunting pressures, farmers and ranchers have enrolled acres with Land Trust, a business that handles the nuances and organization and booking and payment for hunting acres. One landowner returned his guaranteed fees because he could not secure an uninterrupted hunt for the clients due to trespassers from state to private land and bird dog trainers....

Flaxville MT boasts 2 popular bars/restaurants. The owner of the RY Bar kicked 4 different parties of non-resident hunters out of his establishment due to rude behavior. The owner of the Bum Steer stated, "you will never see a 'Welcome Hunters' sign in my establishment"...the non stop pressures of pre season bird dog trainers on private and state land land as well as the hunting season starting TWO WEEKS EARLIER than surrounding states puts our county and Northeast MT at a large disadvantage.

Some claim that we will lose revenue and tourism. I polled Main Street businesses in Scobey and Flaxville as well as the large /only motel in Plentywood. I have pages of quotes and notes I could share, but to summarize: the hardward store is considering no longer selling licenses because it consumes employees' time and brings in marginal revenue for the wages paid/time spent (50cents/license); bars and restaurants unanimously agreed that seasons need to be shortened and that locals are who carry their business; the convenience store acknowledged that season changes may affect revenue but they are willing to absorb it for the larger good of supporting area farmers and ranchers; the grocery store cannot determine what and when to order additional amounts of groceries, so essentially the effect to them would be minimal because their business is the locals; motels relayed concerns on shortening the season and losing booked rooms, BUT upon further discussion it was mutually agreed that changes to the opener for non-residents would undoubtedly increase resident MT hunters to our area and book any available rooms.

Suggestions from the community include: limit the number of non-resident licenses for our county; create a lottery for non-residents; close down all bird dog training completely - adopt a Quiet Season like other states to protect all wildlife and cattle operations at their most fragile; prohibit bird dog training on MT's public lands; non-residents may hunt or train for a combined 20 days a year (perhaps

that would shut down the big commercial trainers coming from TX and SC and GA?); mimic North Dakota's non-resident rules and allow only 7 days of hunting - mayne allow them to return 4 times?; through DNRC create a recreational road permit for counties like Daniels and Petroleum to regain local revenue to maintain roads and bridges;

I believe that there should be a 2-4 bird seasonal limit on sage grouse hunting, and it should run for the entire upland hunting season or at least through November. There is no reason to have a two-bird daily bag limit for the entire month of September.

The decline in the Sage grouse population has to do with more than hunting pressure. While I believe we should be limiting hunting on these birds, there also needs to be a serious focus on the larger issue which is habitat. I have seen the sharptail grouse population around my hometown of Willow Creek all but completely disappear historic lek areas have been developed with no consideration of these native birds or their habitat. The same is happening in sage grouse habitat across the west.

All proceeds from upland-specific tags should be pooled and spent on upland habitat initiatives. We all know that healthy habitat is the key to these birds surviving and the pressures from other land use outside of hunting is a huge issue. Restricting pressure through shorter out-of-state seasons is a start, but an uptick in out-of-state license prices as well as using these funds for habitat initiatives should be considered.

I have never agreed with the hot spotting of Carbon County Partridge. This is a fantastic resource that has been highlighted through an extended season. There has been a dramatic uptick in pressure in this small region since its highlighting through an extended season. The increase in pressure is not only pressure on the bird population but all the other animals that use this region as winter habitat. Being mostly BLM land with few restrictions, the traffic from people on foot as well as off-road vehicles impacts the landscape and the animals that call it home. This region is a special place that should not be highlighted in the way that FWP has for the last handful of years. It is a dramatic oversight and should be adjusted this upcoming season.

Dear Chair Robinson and Commissioners,

I am the secretary of the Headwaters Sportsman Association (HSA) which is a grassroots organization started in 1996 dedicated to promoting increased opportunities for Montana resident hunters and anglers. We have over 100 members who are Montana residents.

Thank you for recognizing the negative impact that increased nonresident hunters have had on the quality of bird hunting in Montana. As you know there have been unprecedented increases in nonresident hunters during the past few years.

Resident hunters tried to get legislation passed last session that would help improve their quality of hunting that has been lost due to increase pressure from nonresidents. Our efforts were well received but new legislation did not get enough votes to become law.

We are grateful that the Department and now our Commissioners have heard our concerns. We support your proposal to limit nonresidents at the beginning of the bird season. However, the reduction in nonresident pressure will be relatively small during those first two weeks.

We suggest you also restrict nonresident participation during the first week of pheasant season too. That will have a much stronger impact. The quality of the hunting experience will be significantly improved for the resident hunters. North Dakota has had this restriction on their nonresidents for the past couple of seasons. We should do likewise.

When nonresidents are not allowed to bird hunt, you may want to allow them to hunt on private property not enrolled in block management. They should certainly not be allowed to hunt any public land or publicly accessible land during blackout periods.

Thank you for the opportunity to provide comments. I am a former Montana resident and am now an Idaho resident, but take 10 days each year to travel and hunt for sharptail grouse in Eastern Montana. I am an avid upland hunter and hunt over 40 days each season. I have witnessed an explosion in pressure from nonresident hunters over the past five years and am concerned with the pressure put on this sensitive resource in Eastern Montana. In addition to the pressure put on the birds, I am concerned with perceived hunter crowding, particularly on properties enrolled in Block Management, state, and federal land. I do not believe the answer to the problem is to adjust the starting date for nonresidents from September 1st to September 15th. This will only exacerbate the perception of crowding, as nonresidents will be lined up on the morning of September 15th to get onto the best BMAs and other publicly accessible land. If the the nonresident start date was moved to the 15th, resident hunters would feel the need to hunt during the first half of September and hit it harder than usual. Likewise, once nonresidents were permitted to hunt starting on the 15th, they would feel the need to fill their bag limits every day and put unnecessary pressure on the coveys they have contact with, potentially wiping whole coveys off the map. It will be a race to the bottom for both residents and nonresidents, and ultimately hurts the birds the most. I respectfully ask that the Department and the Commission pursue alternative means to this very real issue- Montana needs adjustments to the upland bird seasons that only allows nonresidents to hunt for two 7 day periods, not to be used consecutively. This would allow hunters to self-select the dates they prefer and break up the pressure they put on the resource. I understand similar proposals have been brought up in the Montana legislature without moving forward, but agency staff and commissioners should begin conversations with legislators now to educate them on the challenges that are in front of upland bird hunting.

I ask that MFWP consult with upland bird outfitters and local communities in the area to better understand the potential financial impacts the season date adjustment would have on those so reliant to survive in such a short timeframe.

Finally, I believe MFWP should look to Idaho Department of Fish & Game for sage-grouse harvest regulation. A two bird limit per day represents harvest that is too high. Idaho Department of Fish & Game implemented a tag-based system for sage-grouse hunting, broken up by zones, where hunters can purchase between 1 and 2 tags per zone per season, offered at a first come, first served basis. This has allowed for increased harvest data gathering, fine-tuned harvest management based on yearly lek counts, and a reduction in hunter crowding in popular areas.

The challenge is spacing hunters out better to avoid conflict.

I am writing IN SUPPORT of the delayed start for non-resident hunters, and IN SUPPORT of the amended dog training regulations.

In fact, neither Amendment goes far enough. The major magnet for out of state hunters is pheasant season, and the 2-week delay would do nothing to mitigate pheasant season influx of out of state hunters. I respectfully suggest that the Game Bird Amendment be modified to read, "All bird seasons open 2 weeks later for non-residents". In proceeding with the upland game bird season setting process currently before you, we respectfully request that you consider several measures to respond to significant habitat loss through declining CRP program enrollments, increased levels of non-resident dog training on publicly accessible lands and increased levels of upland bird hunting pressure. Upland game bird hunting is a significant driver of rural economies, especially in eastern Montana, but high quality hunting experiences depend on offering a superior bird hunting experience. The decision before you in the coming weeks provides an opportunity to improve both bird populations and the experiences of hunters across Montana.

Specifically, we recommend the following:

- 1) Prohibit Non-Resident dog training activities on wild & captive reared birds on public lands or publicly accessible private lands (including Block Management Areas, Open Fields and Upland Game Bird Enhancement Projects).
- 2) Continue to authorize Resident dog training activities on wild birds on public lands from August 1 to August 31.
- 3) Open Sharp-tailed Grouse, Sage Grouse and Partridge hunting seasons for Non-Residents from September 15 through January 1 as recommended by the amendment proposed by Commissioner Chair Robinson.
- 4) Open Sharp-tailed Grouse, Sage Grouse and Partridge hunting seasons for Residents from September 1 through January 1.
- 5) Close Sage Grouse Management Zone 3 to hunting if spring lek counts drop 45% below the long term average for a third consecutive year in 2024 as recommended by FWP staff. Season should be reopened when populations recover above this threshold.
- 6) Open the Ring-necked Pheasant hunting season the Saturday of Columbus Day weekend for residents and Non-Residents, but restrict Non-Resident hunters to private lands (excluding Block Management Areas, Open Fields, and Upland Game Bird Enhancement projects) for the first week of the season. Open public lands and publicly accessible private lands as noted above to Non-Resident pheasant hunting on the following Saturday.

We believe these changes would provide relief to landowners and lessees of public lands during the summer period, reduce conflict between dog training activities and hunters, reduce hunter crowding and associated conflicts that are occurring while maintaining hunter opportunity and associated economic benefits, and reduce pressure on upland game bird populations.

We appreciate your consideration of these recommendations and look forward to working with you to continue to improve Montana's upland game bird hunting for future generations.

To whom it may concern:

As a non-resident hunter who arrives in Montana without a dog and brief three day window of opportunity to hunt for sharptails and Hungarian partridge, I am dismayed by the attempt to reduce the number of days that we can spend in the field. Rather than limit days afield, perhaps policy makers should consider reducing daily bag limits or creating a maximum bag limit per season. This would limit the kill and incrementally reduce hunter traffic on public lands.

Let's acknowledge the substantial economic contributions made by non-resident hunters. When we visit your wonderful state, we are not just carrying shotguns and sporting gear; we bring vital economic support to local communities. From guides and outfitters to hotels, bars, and stores, the influx of these visitors is a lifeline. In rural areas where I hunt—just a few miles from the Canadian border—I rarely see another hunter or another vehicle for that matter over the course of three days. But I do spend money on my guide and sleep in his lodge. I also spend a bit of time at one of the few businesses in town—extending greetings to the local bartender. This establishment is one of the few remaining in the town—a place and region that has faltered significantly under the weight of commercial agricultural expansion over the last few decades.

The transformation of agriculture has undeniably reshaped rural landscapes. Large-scale farming operations have streamlined and industrialized what was once a mosaic of family-owned farms. This shift, while economically understandable, has hollowed out many small towns. Schools see declining enrollments, local businesses shutter, and the workforce dwindles. The local football team from the 1980s is no longer as families disappeared from an even more barren landscape. Now these same communities could be faced with further economic pain as some in the legislature propose changes to hunting laws change for non-residents. While I can see some merit in the proposed non-resident argument, I humbly argue that it is not a balanced view in light of the above reflections. In fact, I suspect outfitters will disappear as their already brief season will truncate further, negatively impacting the economic viability of their operations. The few remaining small business in these towns will suffer further as well.

This observation does not just speak to one community but rather a panoply of small towns checkered across this great state.

Non-resident hunters offer a counterbalance to this trend.

Rather than making wholesale changes to the bird seasons, I suggest you seriously consider a bag limit for the entire season so that non-residents can spend days in the field, perhaps lighten their game bag a bit, yet continue to have access to a landscape where we all feel most at peace.
