Ducks Unlimited appreciates the efforts made by the Montana Fish and Wildlife Commission to conserve wetland habitats, expand opportunities for public recreation, and work in concert with local farmers and ranchers who produce food, support a local economy, and conserve valuable habitat concurrently. In that spirit, we are commenting to support the 414 acre addition to the Isaac Homestead Wildlife Management Area (WMA) that will connect the currently separated east and west units of the WMA.

On behalf of the Montana Wildlife Federation (MWF), Montana's oldest and largest hunter and angler-based conservation group, founded in 1936 by conservationists, landowners, hunters and anglers. MWF is a 501(c) 3 nonprofit organization comprised of staff, more than 5000 members, and 14 affiliate clubs throughout the state who share a mission to protect and enhance Montana's public wildlife, lands, waters, and fair chase hunting and fishing heritage. Please accept these comments in full support of the Isaac Homestead Wildlife Management Area (WMA) Addition.

Our members hold a deep appreciation for pristine landscapes, accessible public lands, and healthy wildlife populations. Consequently, we are enthusiastic about the prospect of this proposed addition to the current WMA, particularly given its potential to safeguard habitats for mule deer, white-tailed deer, pronghorn, many waterfowl species, greater sage-grouse, sharp-tailed grouse, and others. We are also enthusiastic about noxious weed control and the protection and enhancement of the predominantly two main habitats throughout the property both the high sagebrush steppe and the riparian river bottom.

The proposed acquisition would make the WMA into one, publicly accessible unit. The west unit is larger and is accessible via a county road. The east unit historically was accessible; however, the river channel migrated north into a steep embankment, completely washing away the road. Currently, the public is only able to access the east parcel via the Yellowstone River, utilizing FWP fishing access sites (FAS) located upstream or downstream of the WMA. Despite that, even access from the upstream FAS is challenging as there is a diversion dam that limits passage by watercraft. By acquiring this 413.929 acres of land that separates the two parcels and installing a FAS, FWP would be increasing public access to high quality lands in an area where access has traditionally been very limited in opportunity for the public. Public access is available on the Lower Yellowstone River, though these limited sites are heavily used, which identifies a need and a desire for more.

We respectfully request that the funding for this addition be sourced exclusively from Habitat Montana allocations. Habitat Montana was specifically established and financed for acquisitions of this nature. While we acknowledge the rationale behind utilizing Migratory Bird Wetland funds given the significance of waterfowl species in the river corridor, we contend that these funds would be more effectively utilized for wetland habitat easements and enhancements.

The Isaac Homestead Wildlife Management Area Addition encapsulates the values of the Montana Wildlife Federation, and we endorse its advancement. We extend our appreciation to the Department for their facilitation of this initiative and for identifying opportunities for access, conservation and economic development along the Lower Yellowstone.
