On behalf of the Montana Wildlife Federation (MWF), Montana's oldest and largest hunter and angler-based conservation group, please accept these comments in support of the Assignment of Public Hunting Access for the Case Ranch.

We thank FWP and Five Valleys Land Trust (FVLT) for their collaborative solution that both fulfills the agreements of the conservation easement held by FVLT and the recognition that FWP is best suited to manage and provide for perpetual public hunting access. This is a win-win.

This 2,330-acre wildlife-rich property is close to the population hub of Missoula, and not only offers great big-game hunting opportunities on its deeded acres, but also provides and/or improves public access to tens of thousands of adjacent public lands.

Since Block Management is a hunter impact program, not a hunter access program, this also allows the landowners to receive compensation for the impacts of allowing equitable public hunting access, something we support and greatly appreciate. But outside of the separate and voluntary hunter impact program of Block Management, it's worth noting that no FWP funds will be used to receive this access assignment.

Therefore we enthusiastically encourage the Commission to adopt Alternative A, and to approve FWP's proposal to accept the assignment of public hunting access rights on Case Ranch from FVLT.
