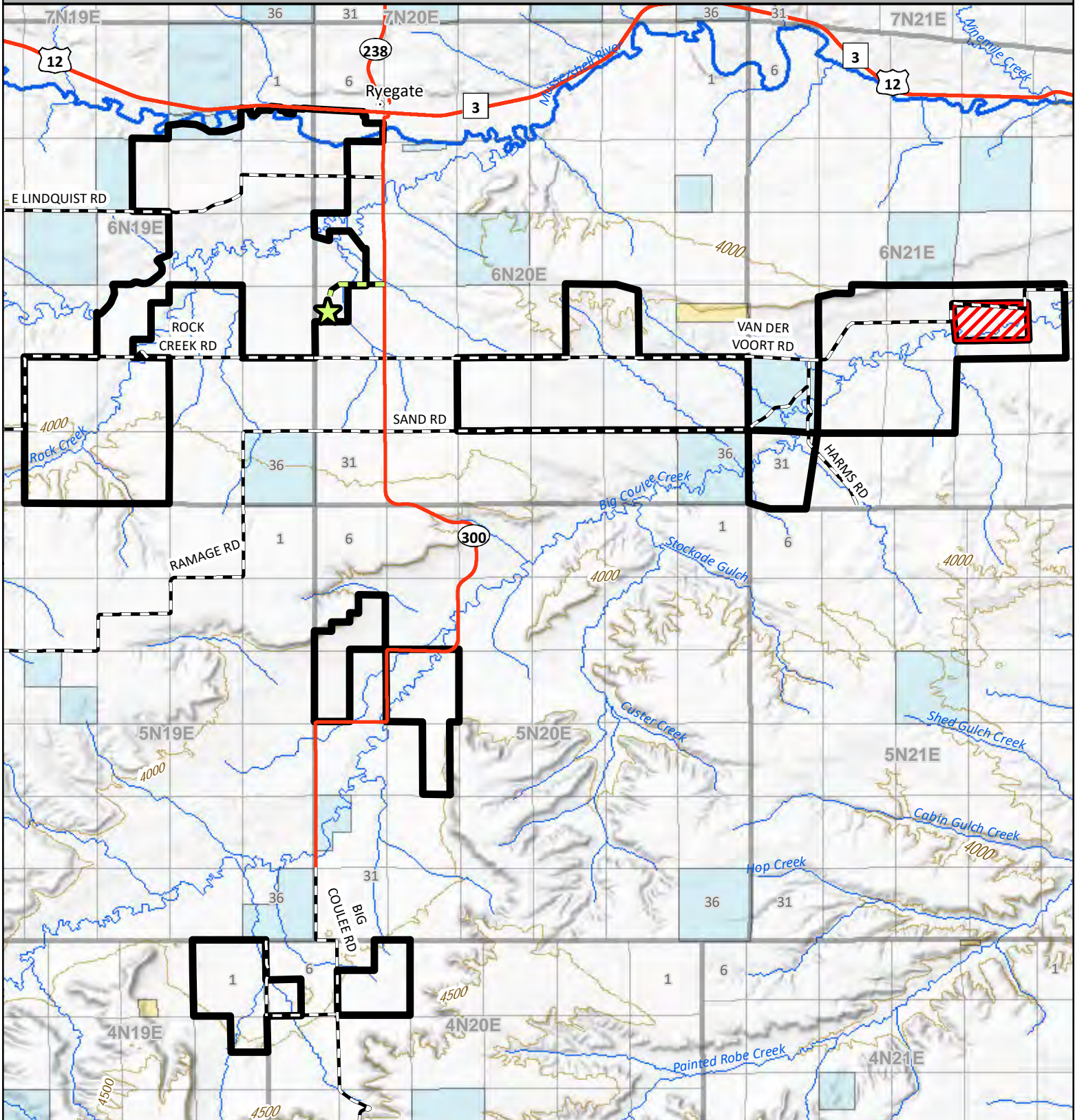

GENERAL INFORMATION

All species may be hunted on this BMA with valid licenses during legal hunting seasons unless otherwise restricted.

PRIMARY HUNTING OPPORTUNITIES:

Mule/Whitetail Deer, Antelope, Upland Birds

PERMISSION REQUIREMENTS

- PERMISSION SLIPS CAN BE OBTAINED THROUGH THE SIGN-IN BOX- VALID UP TO THREE CONSECUTIVE DAYS.**
- After 3 days, Hunters can obtain written permission by calling 406-568-2210 (starting August 22nd) until all reservation periods are full.
- Every hunter is required to carry the permission slip at all times while hunting on this BMA.

PARKING & ACCESS REQUIREMENTS

- Hunters are required to stay on established roads. No off-road motorized vehicle use.
- Vehicles may be parked along ranch roads within 20 feet. ATVs and motorcycles not allowed.
- Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.

HOW TO GET THERE

From Ryegate:

- » South on Hwy 238 to Access Rd **2.3mi**
- » Access Road to Ranch Headquarters **0.7mi**

ADDITIONAL RULES

- All requested information and signature are required for use of this BMA. Access to the BMA is not valid if the sign-in slip is incomplete or unsigned.**
- All people accessing the property must sign in**
- Non-motorized game retrieval only.
- Do not enter or shoot into safety zones. Be aware of neighboring houses, ranch buildings, and cattle.
- Fires are not allowed at any time on this hunting access area.
- Do not enter ranch buildings, corrals, or other structures.
- Commercial outfitting is prohibited.
- Fish & Wildlife Commission-approved hunting regulations apply. Hunters are required to possess the necessary hunting licenses for the species and hunting districts they are hunting.
- BMA restrictions do not apply to legally accessible public lands shown within the BMA boundaries.
