



Corrections to the 2024 Printed Deer, Elk, Antelope Regulations and Legal Descriptions

Deer, Elk, Antelope Regulations

- Page 104 elk B license 004-00 general season dates to begin on Oct. 21 (instead of Oct. 26) in HD 446: Commission adopted change.
- Pages 55, 56, 58, and 59 adjust the antlered buck white-tailed deer and either-sex white-tailed youth season dates to begin on Nov. 2 (instead of Nov. 4) in HDs 210, 211, 214, and 216: Commission adopted change.
- Page 65 HD 280: Commission adopted correction to elk season dates in HD 280 for general license brow-tined bull or antlerless elk from Sept. 27 to Sept. 26.
- Page 11: Season dates chart: Correct dates

Legal Descriptions

- Modified BMU 520 legal description
520 Beartooth Face: Those portions of Carbon, Park, Stillwater and Sweet Grass Counties lying within the following described boundary: Beginning on Interstate 90 at Big Timber, then east along said interstate to its intersection with State Route 78 at Columbus, then south along said route to State Route 421, then easterly and southerly along said route to US Highway 212 near Joliet, then northerly and easterly along said highway to its junction with US Highway 310 at Rockvale, then southerly along said highway to its intersection with State Route 72 about one mile south of Bridger, then southerly along said route to the Montana-Wyoming Border, then westerly along said border to the Custer-Gallatin National Forest Boundary south-east of Albino Lake, then northerly and westerly along said boundary to the Park-Stillwater County line, then north and west along said line to the Custer-Gallatin National Forest Boundary near Timberline Mountain, then northerly along said boundary to the head of the East Boulder River, then north along the East Boulder River/Main Boulder River divide to the north end of Contact Mountain, then south and west off said Mountain to the Boulder

River at the confluence with Falls Creek, then south along said creek to the intersection with the Main Boulder Rd, then north along said road to the intersection with the US Forest Service administrative boundary, then northwest along said boundary to Mission Creek, then north down Mission Creek to Interstate 90, then east along said interstate to Big Timber, the point of beginning.

- New BMU 530 legal description
Upper Boulder Those portions of Park and Sweet Grass Counties lying within the following described boundary: Beginning at the intersection of the Main Boulder Rd and the US Forest Service administrative boundary, then northwest along said boundary to Mission Creek, then south along said creek to Elephant Head Mountain, then south along the Yellowstone River-West Boulder Divide to Mt. Cowan, then south and east along the Boulder River-Mill Creek Divide to Boulder Mountain on the Main Boulder River/West Boulder River divide, then south along the Main Boulder River-Mill Creek divide through Silver Pass and The Pyramid to Crow Mountain, then south and east along the Main Boulder River-Hellroaring Creek divide through Boulder Pass and Shepherder Peak, then south and east along the Main Boulder River-Buffalo Fork divide, then north and east along the East Fork of the Main Boulder River-Slough Creek divide to Columbine Pass and the boundary between the Gallatin and Custer National Forests, then north along said boundary to the head of the East Boulder River, then north along the East Boulder River/Main Boulder River divide to the north end of Contact Mountain, then south and west off said Mountain to the Boulder River at the confluence with Falls Creek, then south along said creek to the Main Boulder Rd, then north along said road to the intersection with the US Forest Service administrative boundary, the point of beginning.
